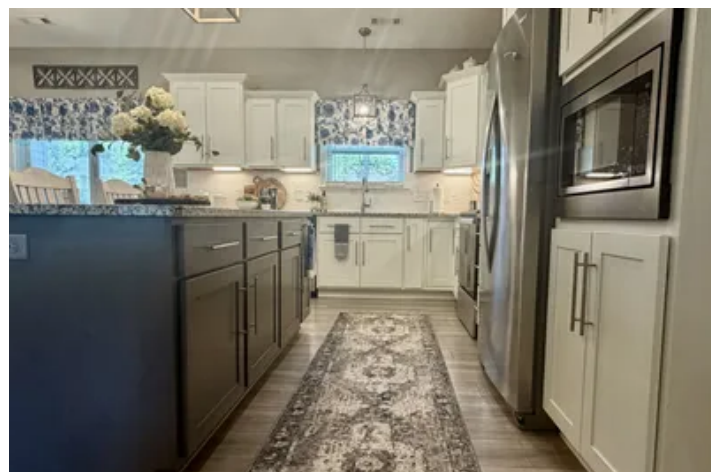

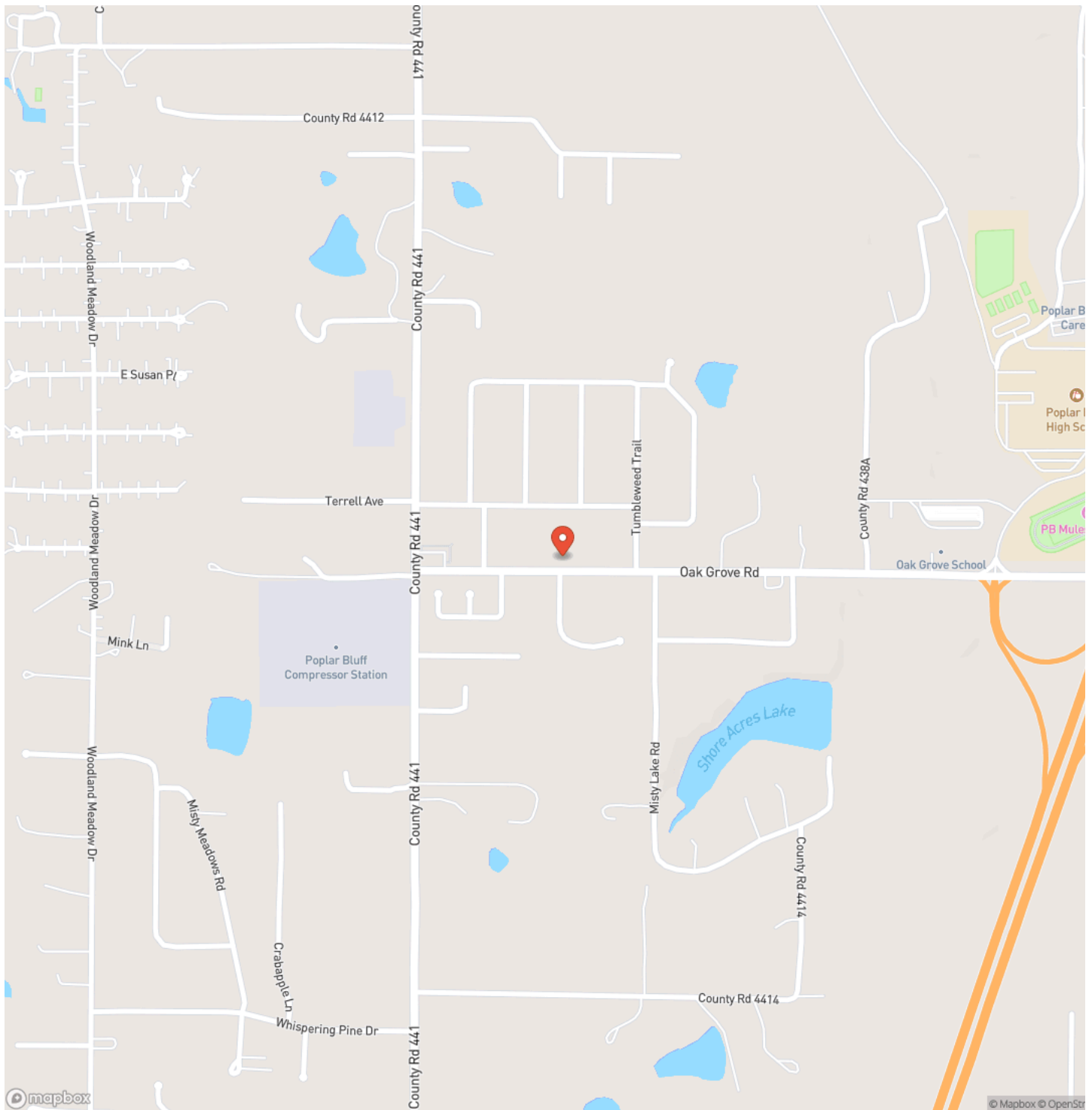

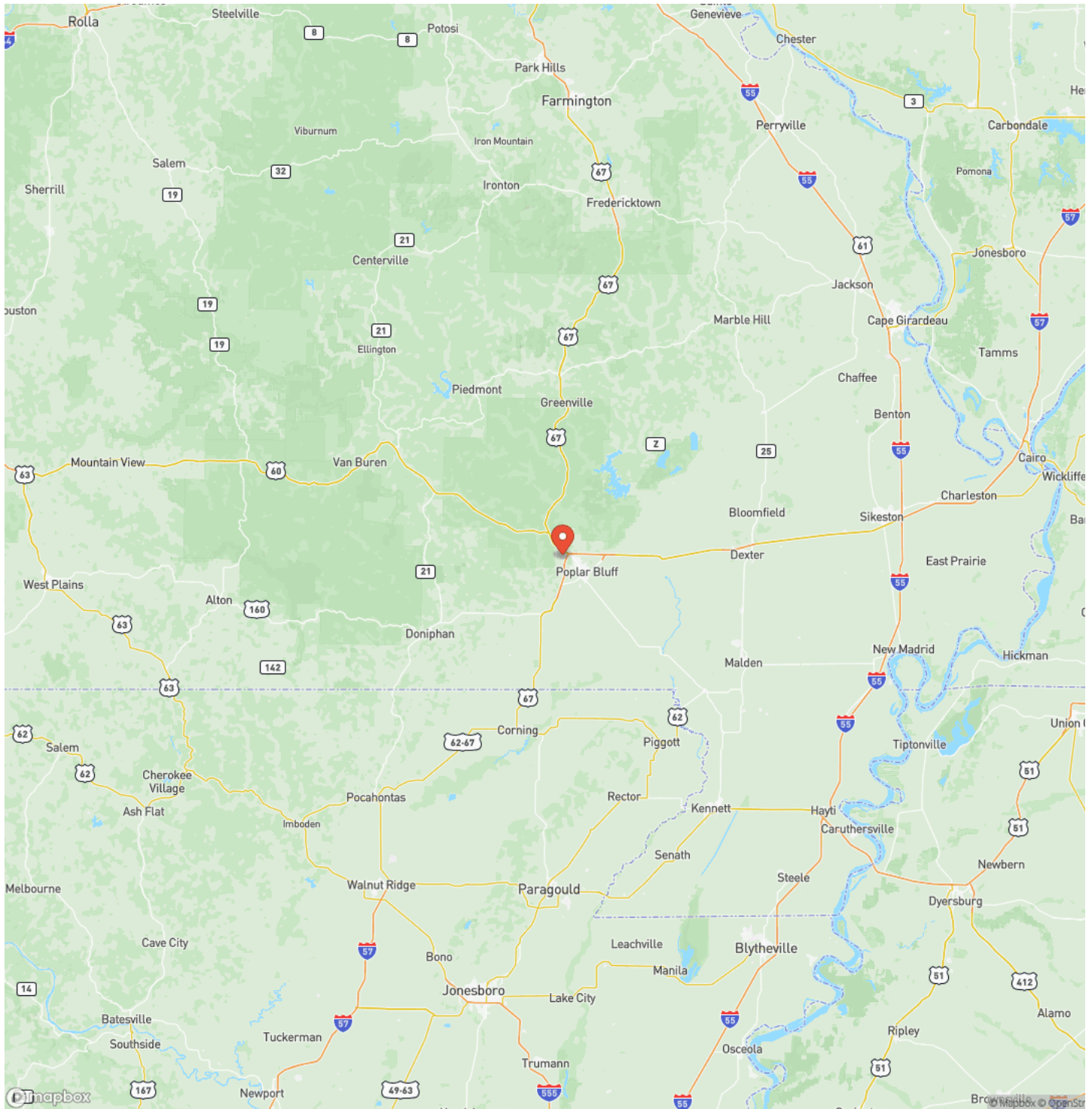


Locator Map

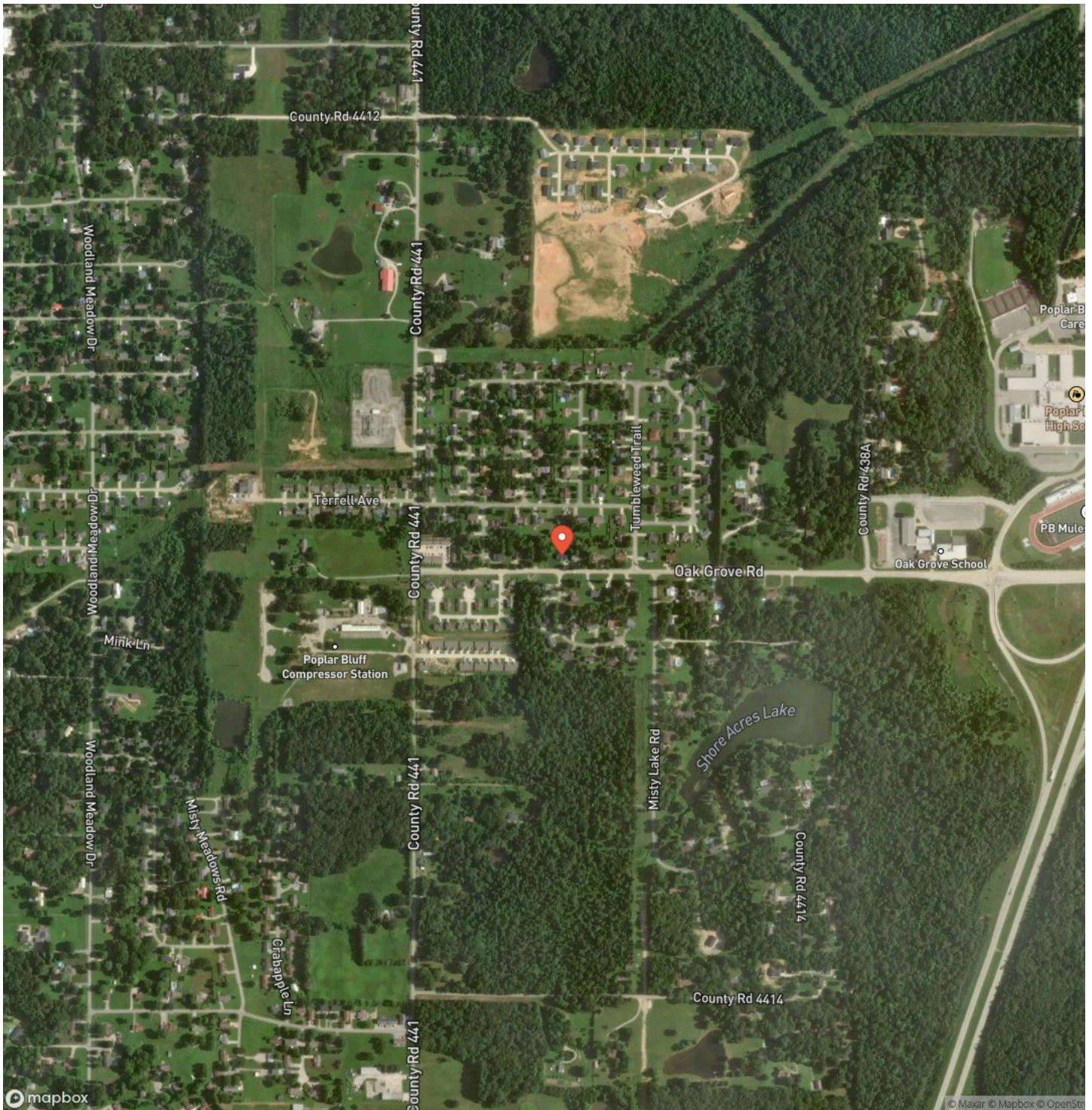
