Executive Summary

LoMac Farms is a large farm in northeastern Montana that is 15,964± deeded acres consisting of 12,376± acres of loamy cropland and 3,582± acres of rangeland. The farm is characterized by flat to slightly sloping farm fields with interspersed grassy draws in some parcels. The area is known for its quality durum, spring wheat, hay, peas, lentils, and canola. The improvements include 500,000± bushels of grain storage, heated shop, spray center, two homes, and various outbuildings located on a single tract adjacent to Montana Highway 250 approximately 25 miles north of Wolf Point and 40 miles southwest of Scobey. Grain terminals are easily accessible via quality county and state roads.
