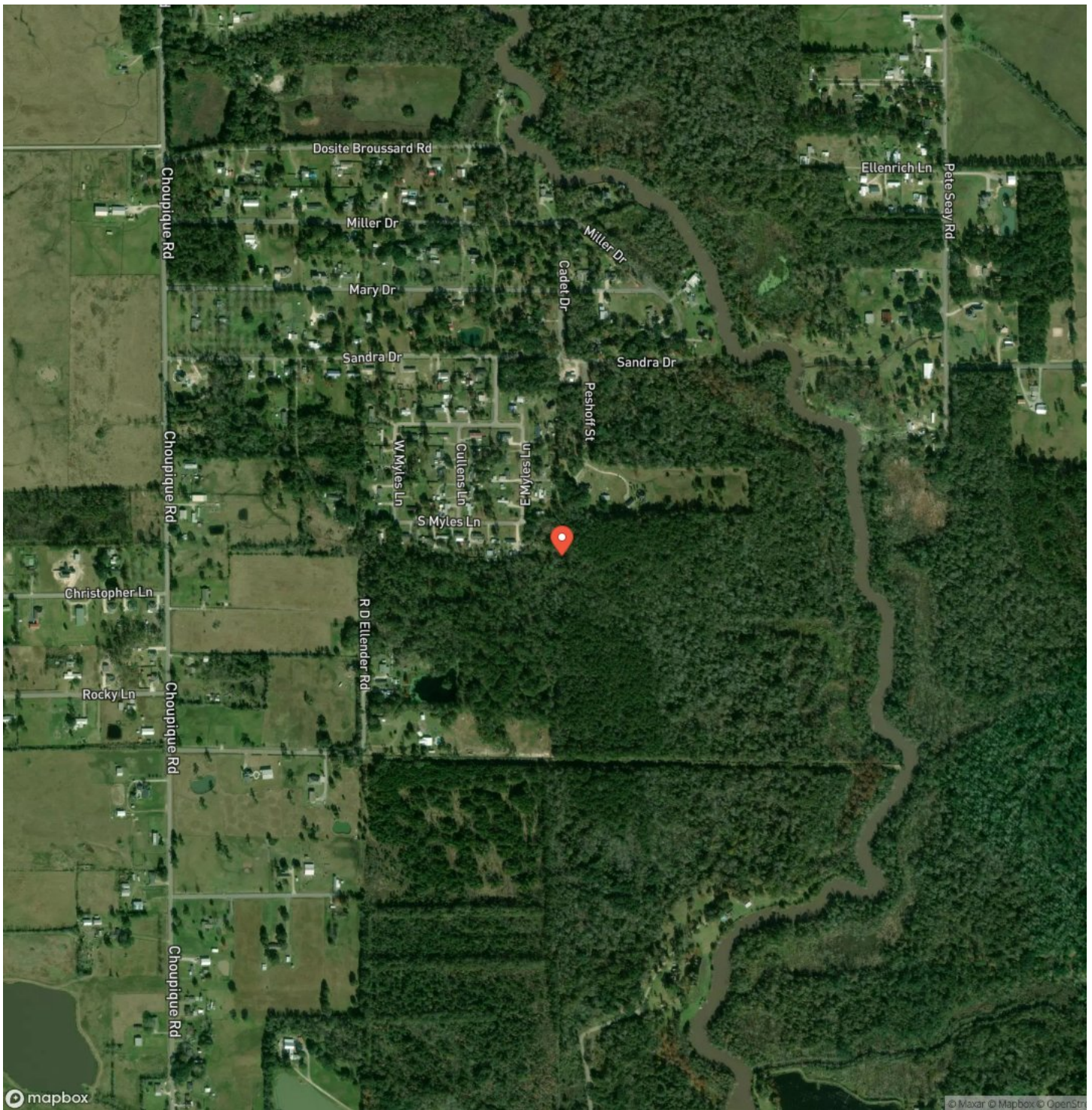
Locator Map
