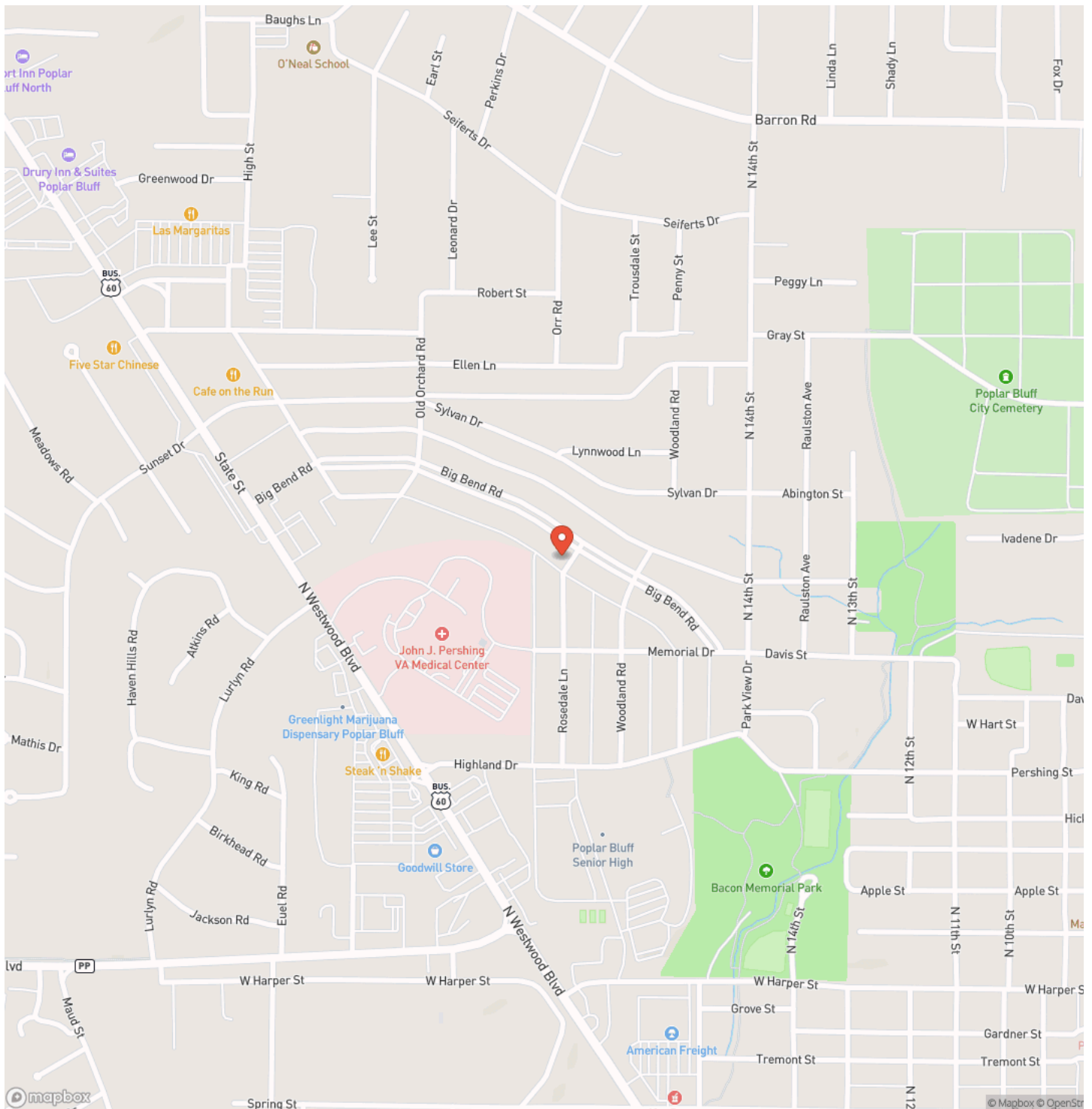

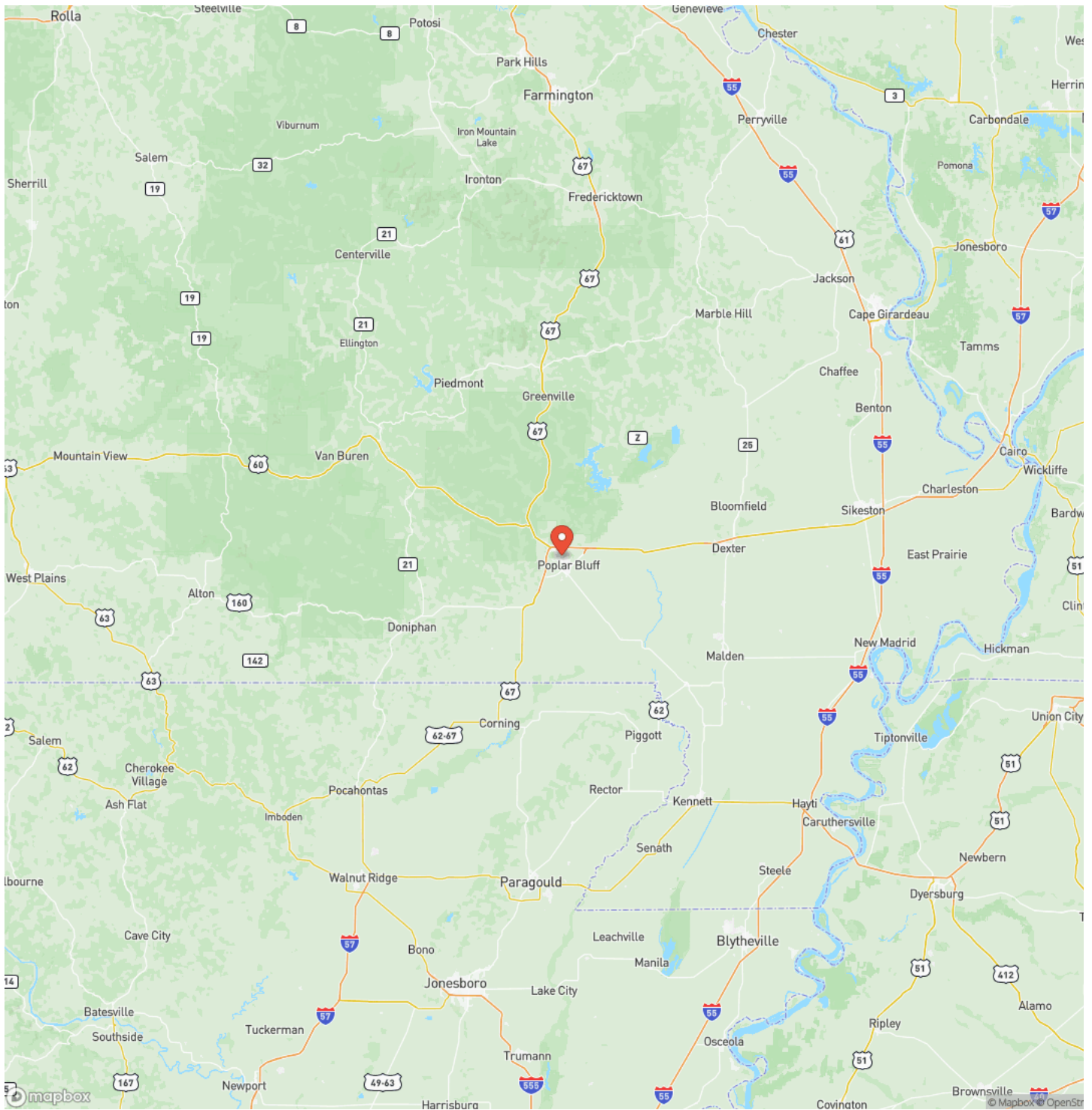

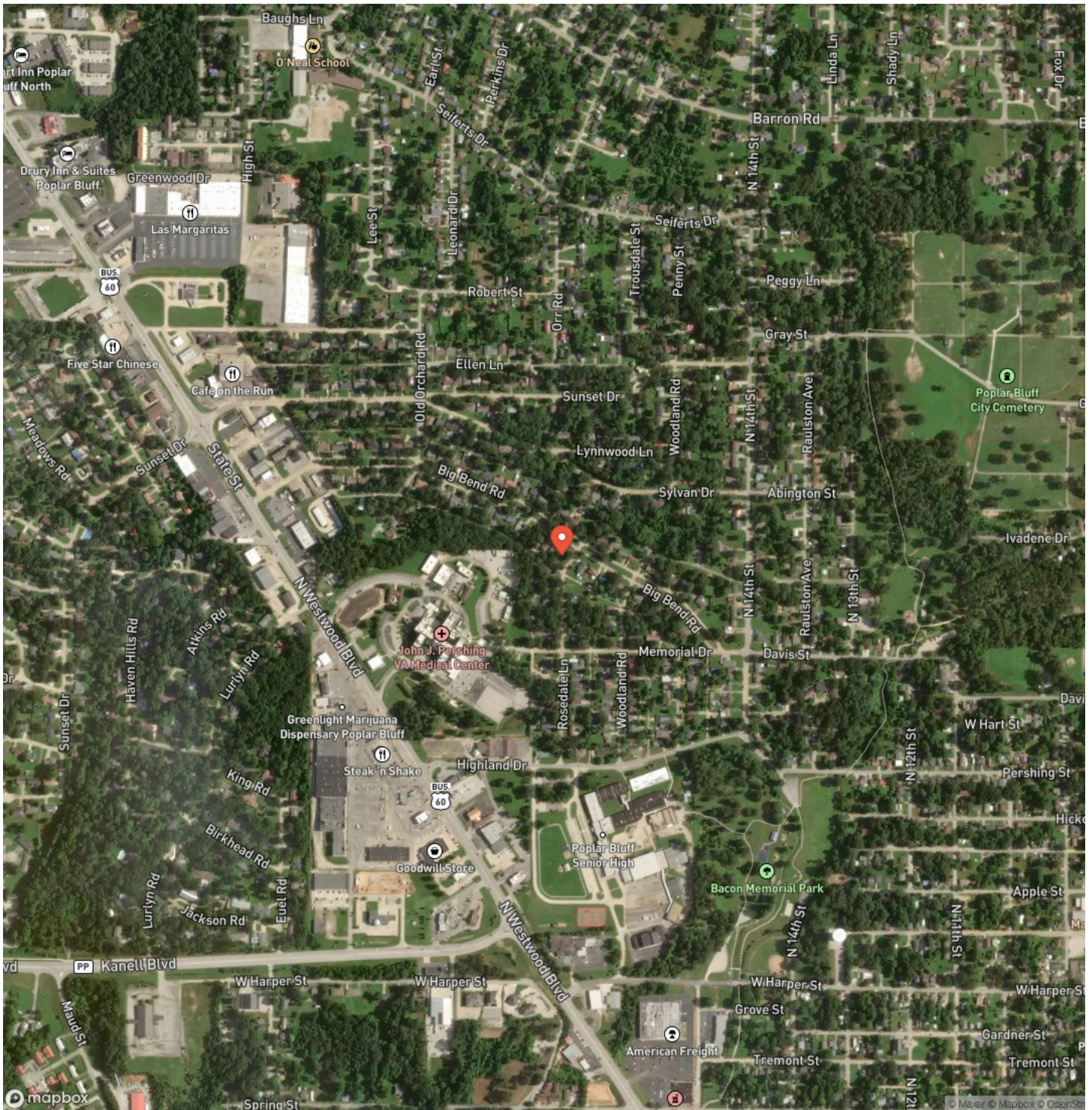
## Locator Map
