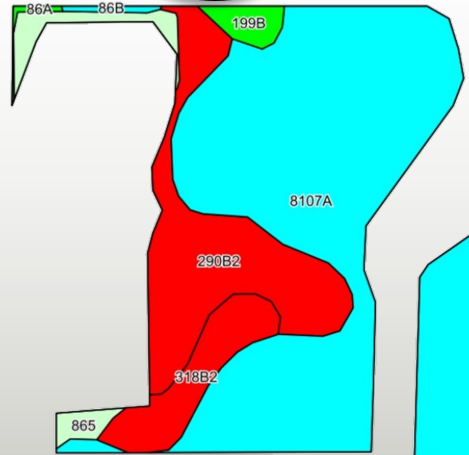
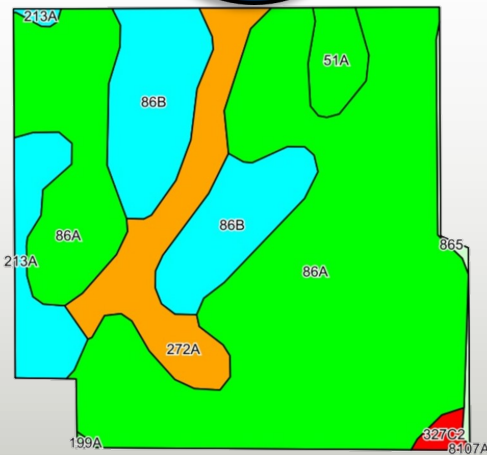

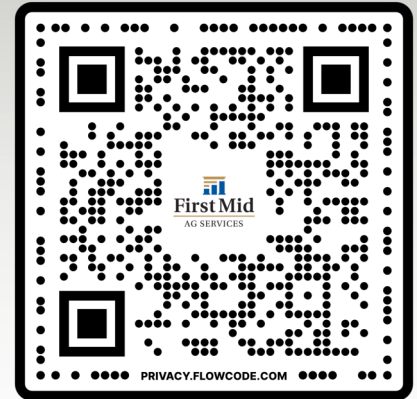

Cropland Soils

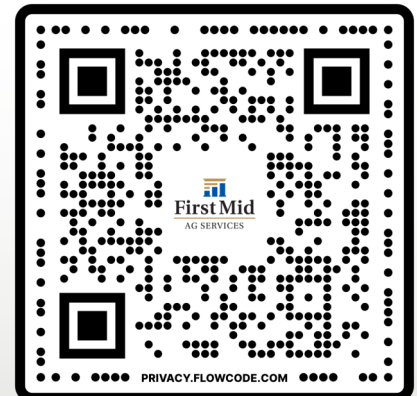
