
EXECUTIVE SUMMARY

The centerpiece of Soaring Eagle Retreat is a 5,471± square-foot, custom-built log home that is situated to take advantage of unending views of the Pioneer and Boulder Mountains while remaining hidden from the valley below. Built in 1992, the two-story residence was designed for comfortable, casual mountain living and features four bedrooms, three-and-a-half baths, two kitchens, and a three-car garage with shop space. Upon reaching the residence at the end of the private, forest-lined drive, one is immediately struck by the setting's tranquility, seclusion, and splendor. Once past the entrance, a mountain wonderland awaits those craving a slower pace with dreams of living in harmony with nature, skiing fresh powder, hiking, and cycling endless mountain trails.



Overall, the residence represents an idyllic retreat with a thoughtful layout that enables family and friends to gather easily or retire to quiet spaces.




