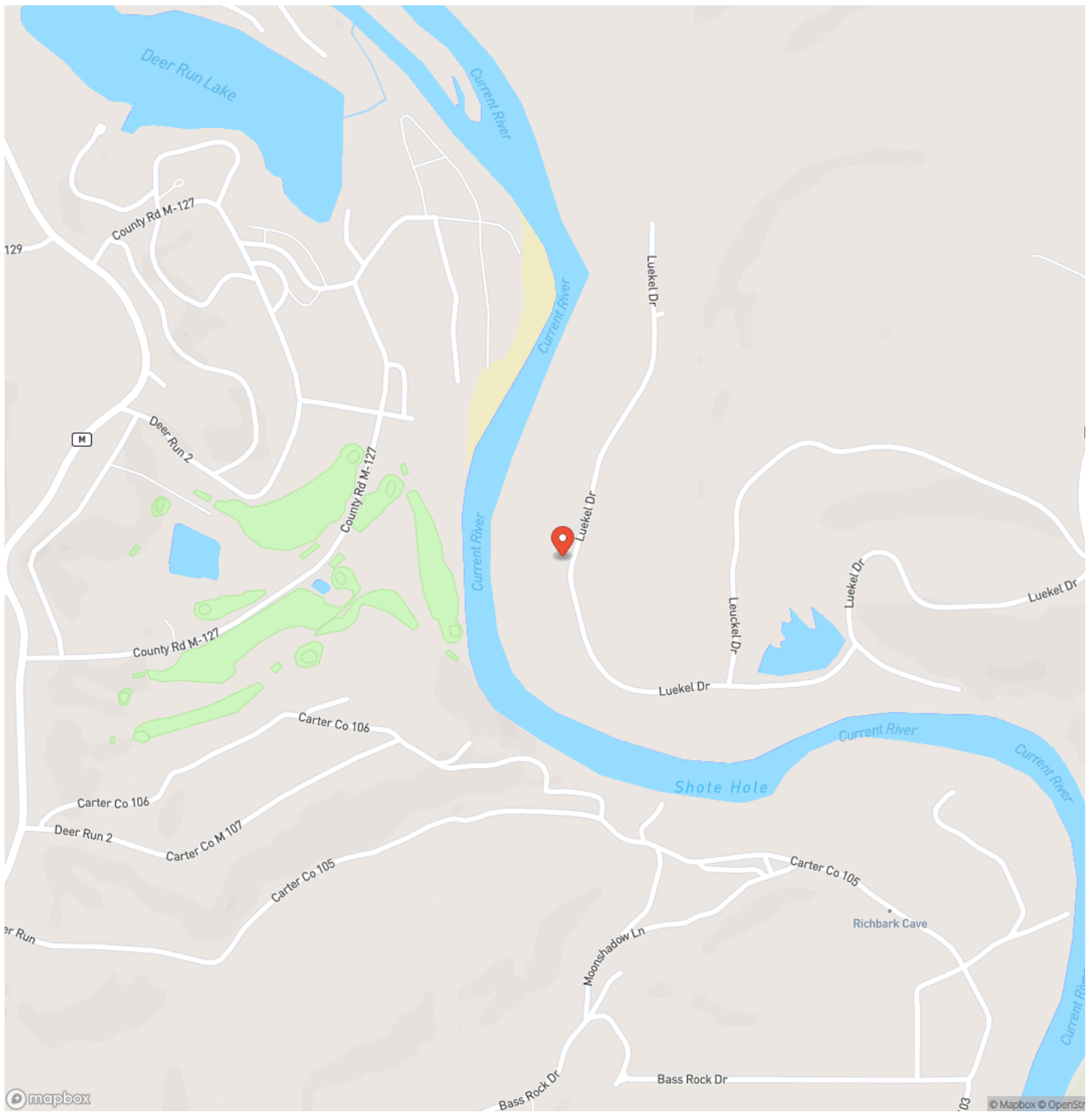

Embrace a life of ease and natural beauty at this hidden gem, where adventure is always just around the corner.

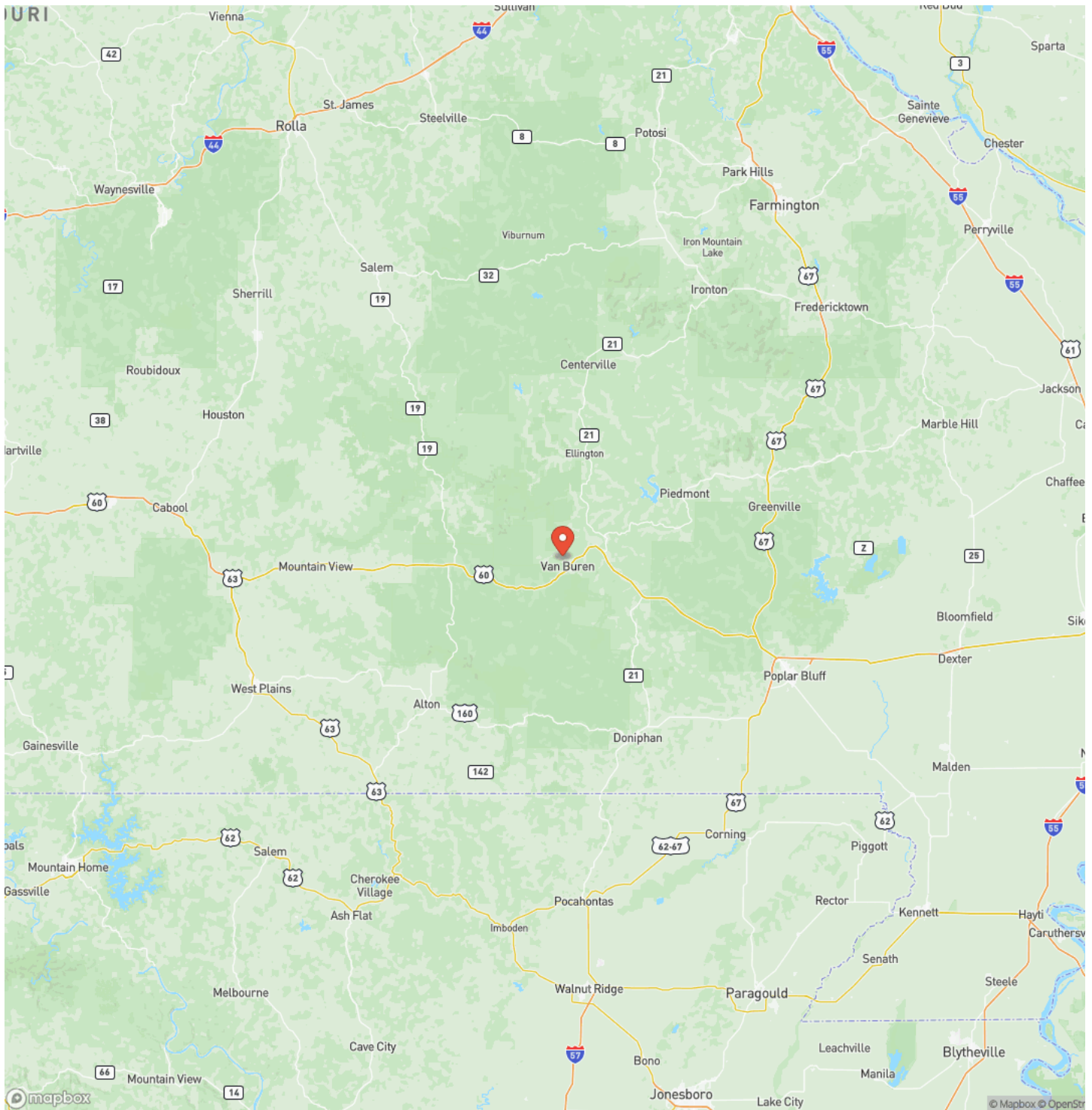
