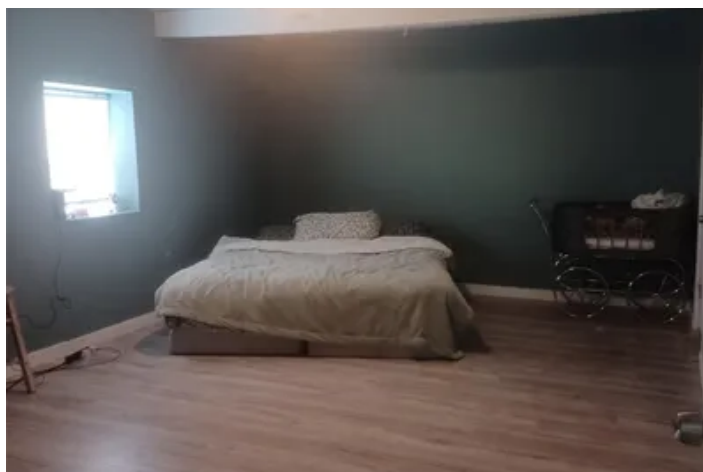

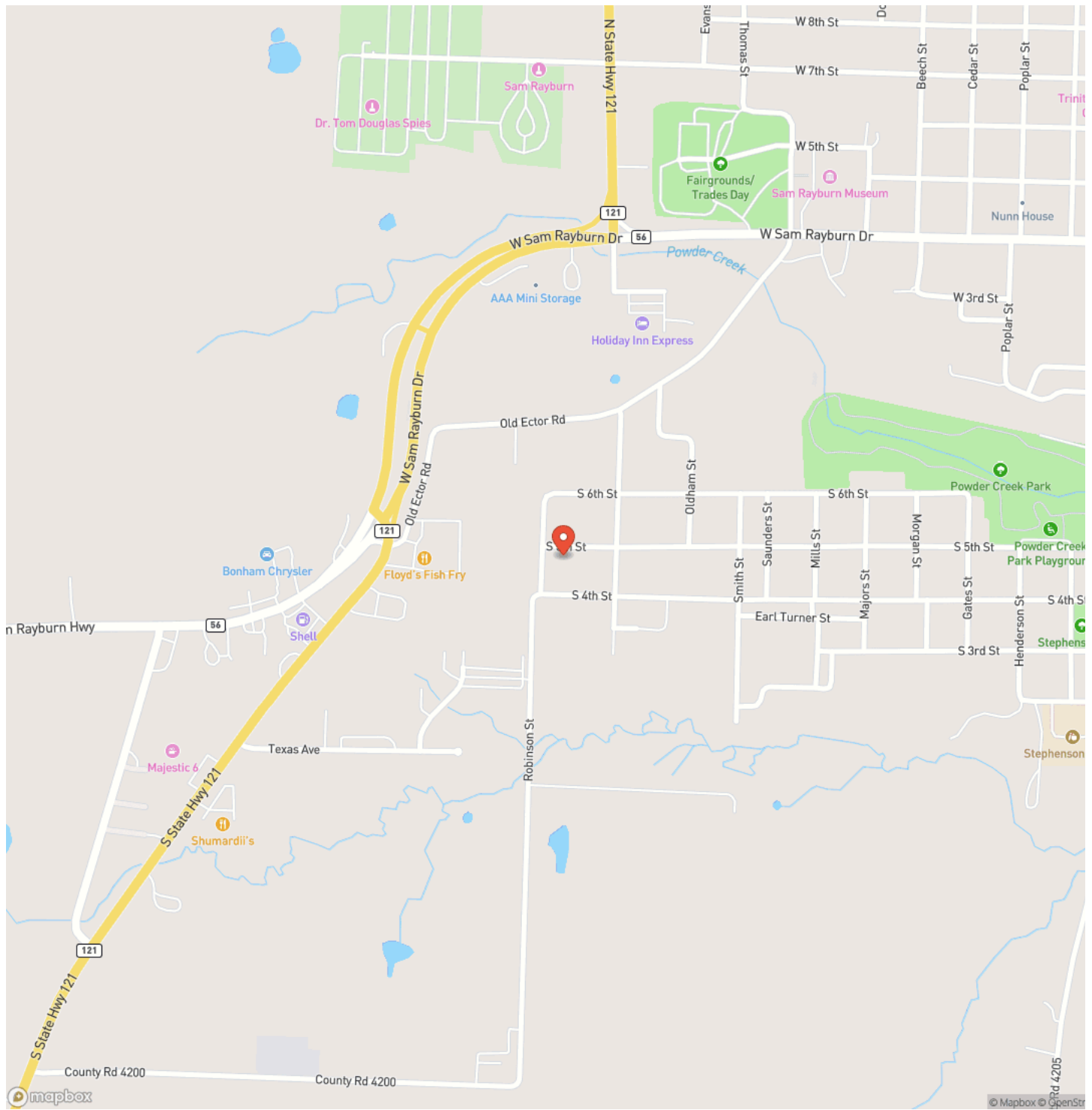

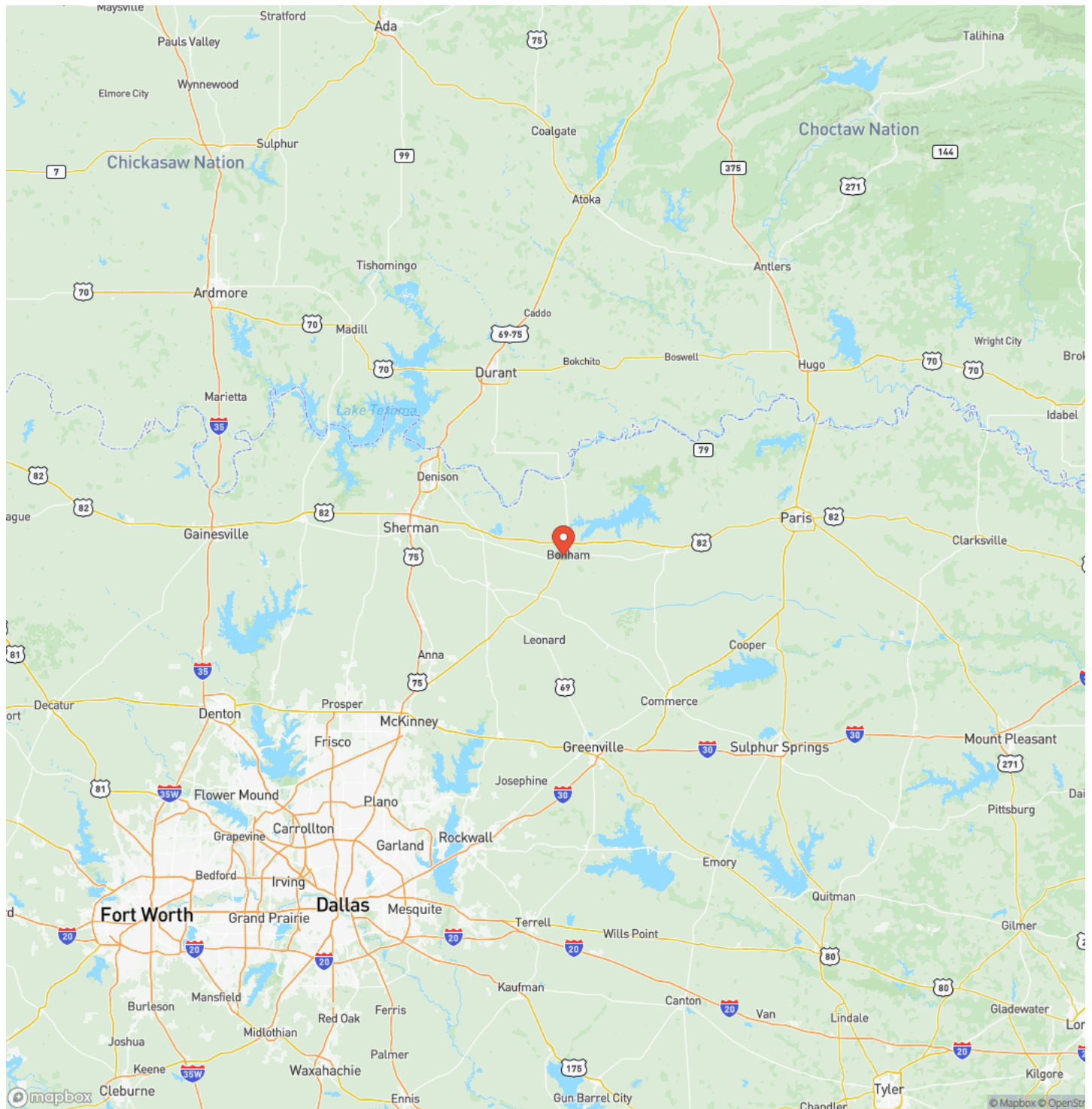

Locator Map



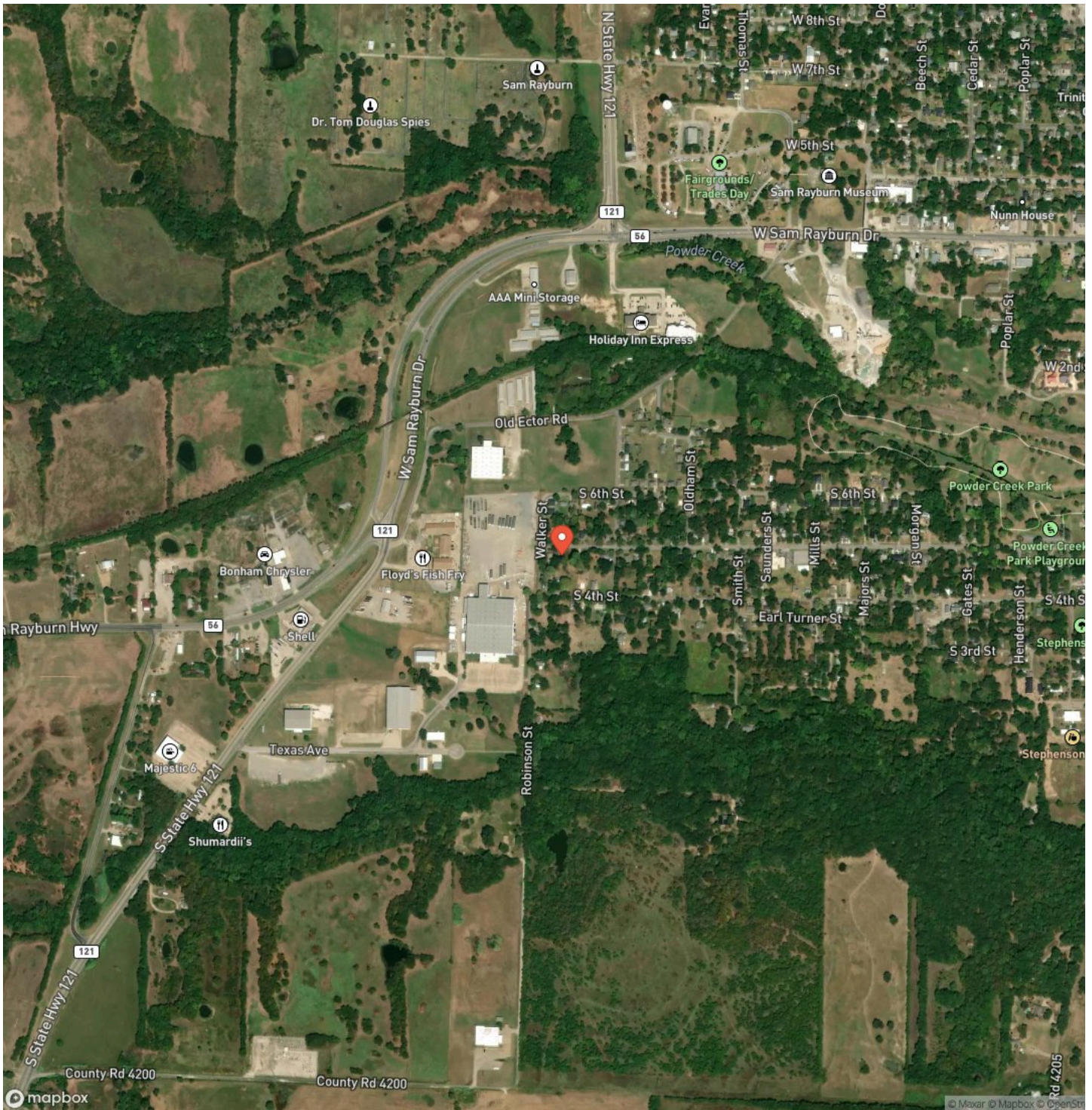
