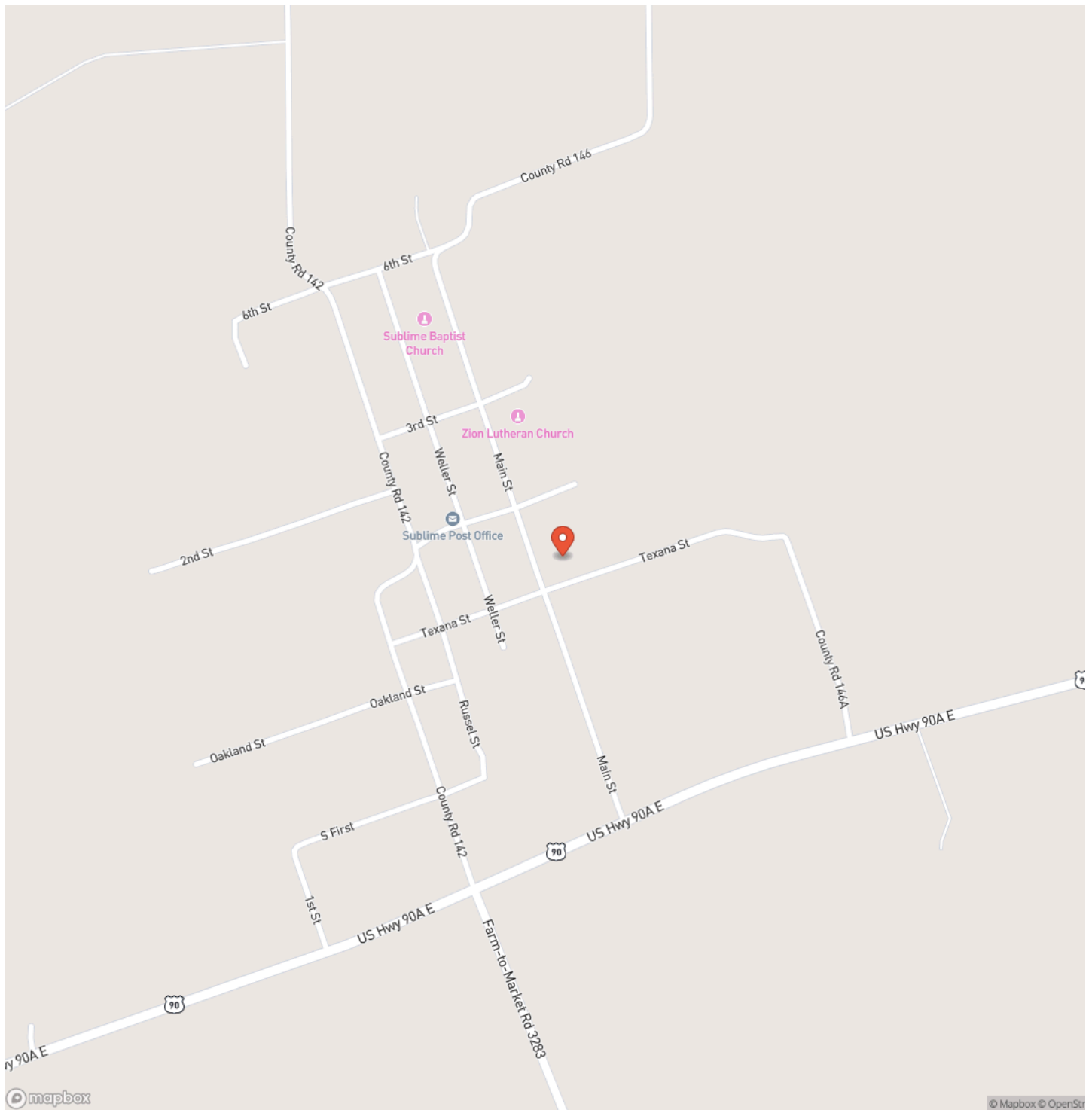

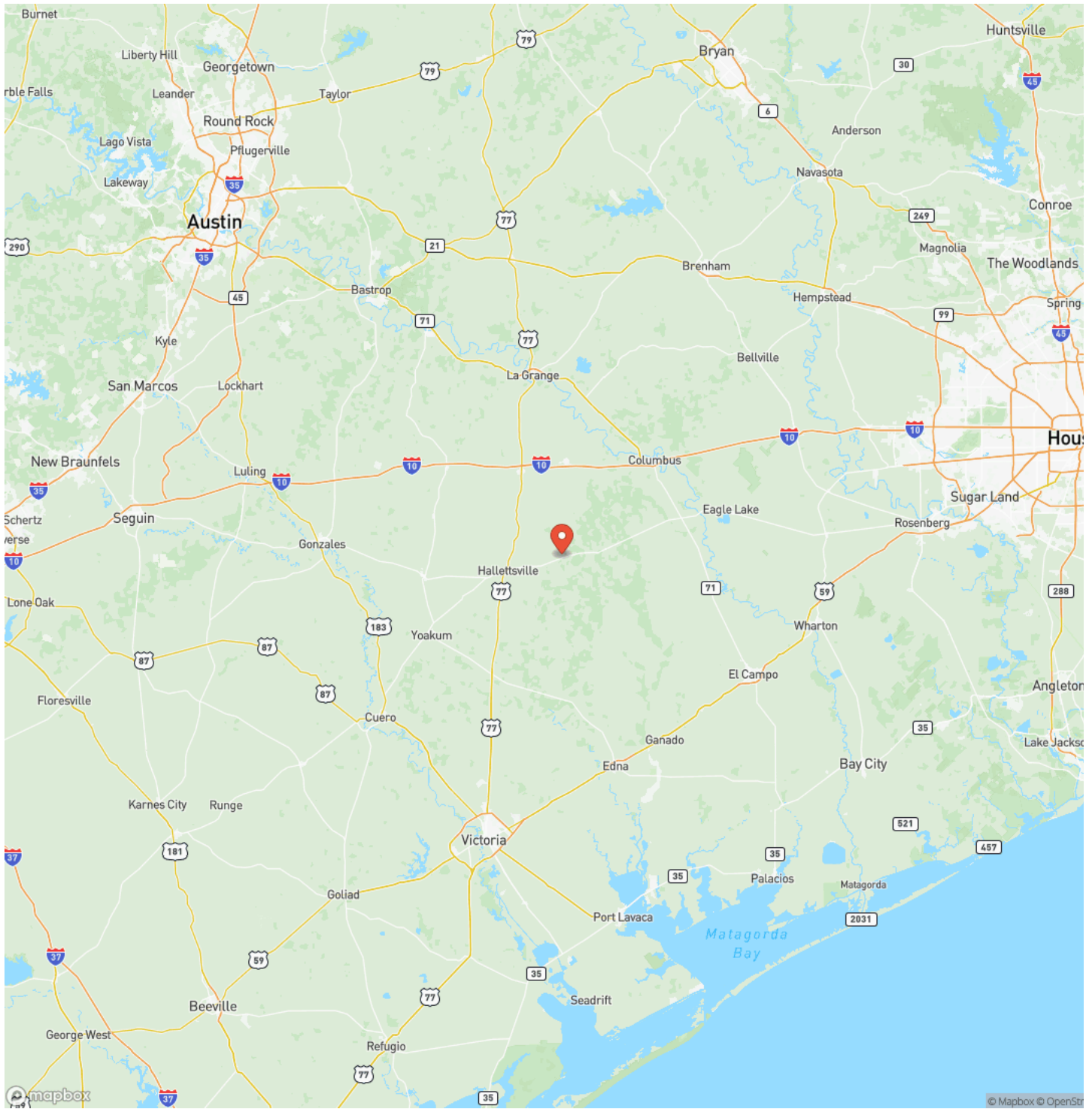

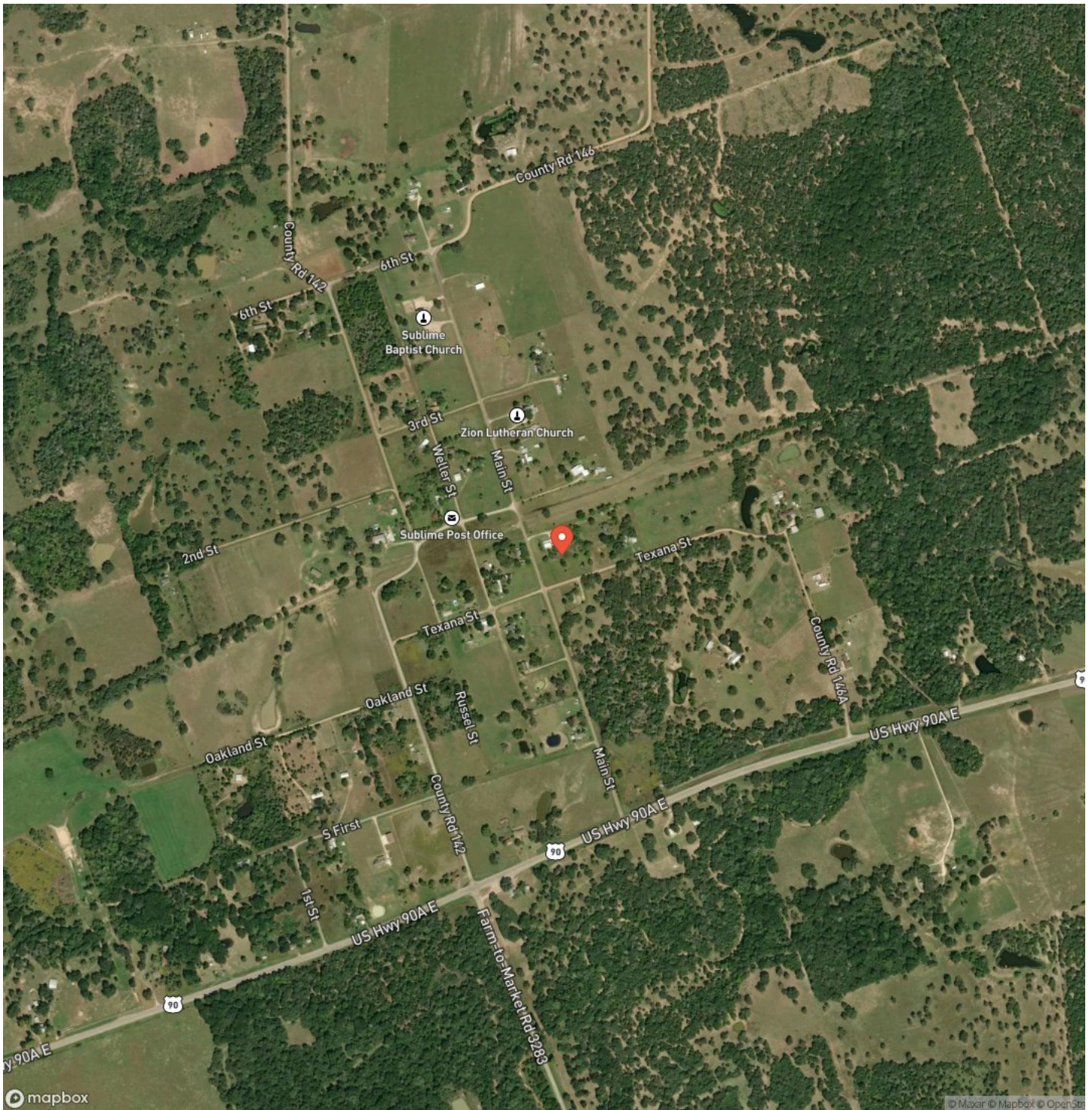
Locator Map
