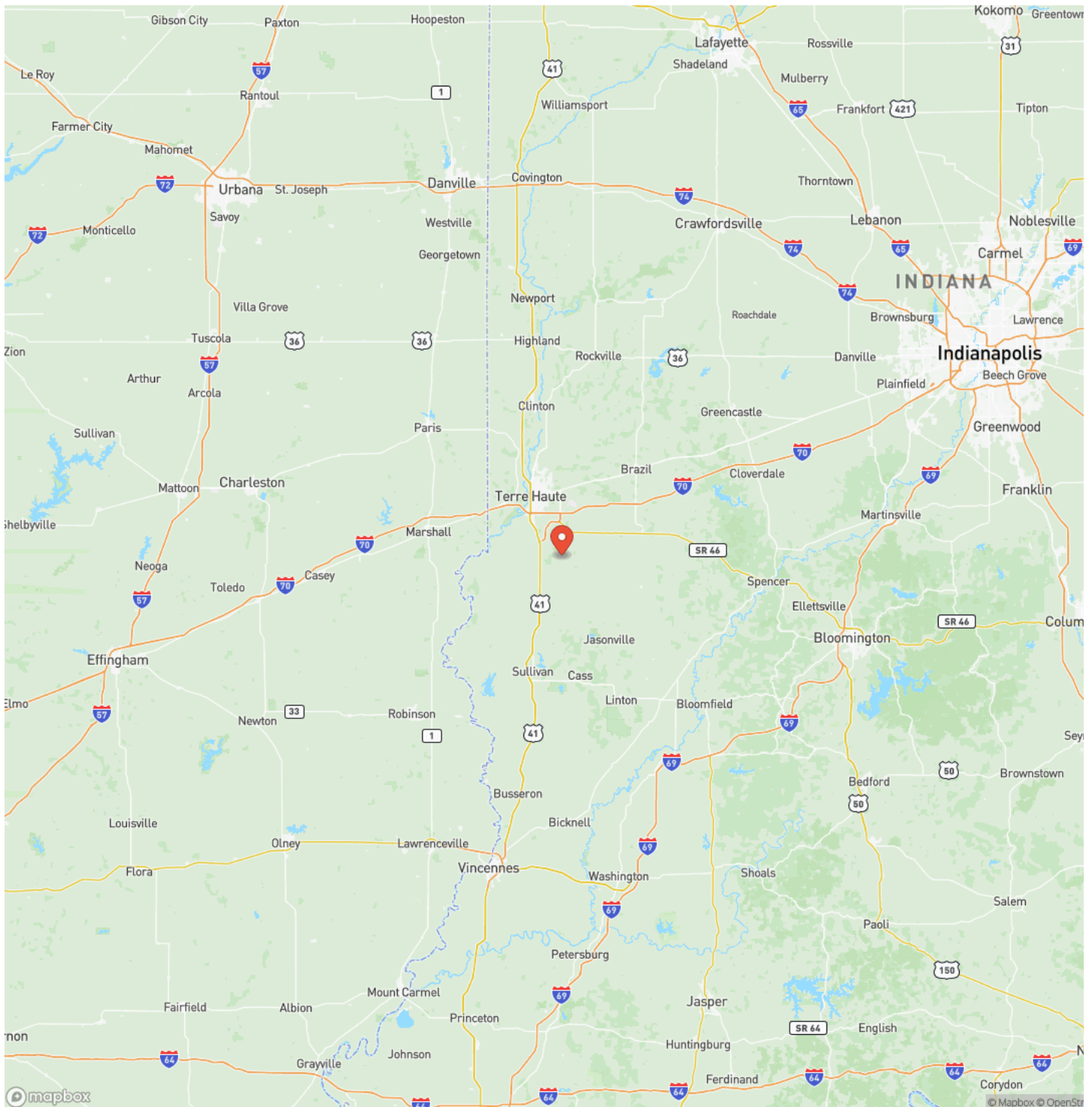

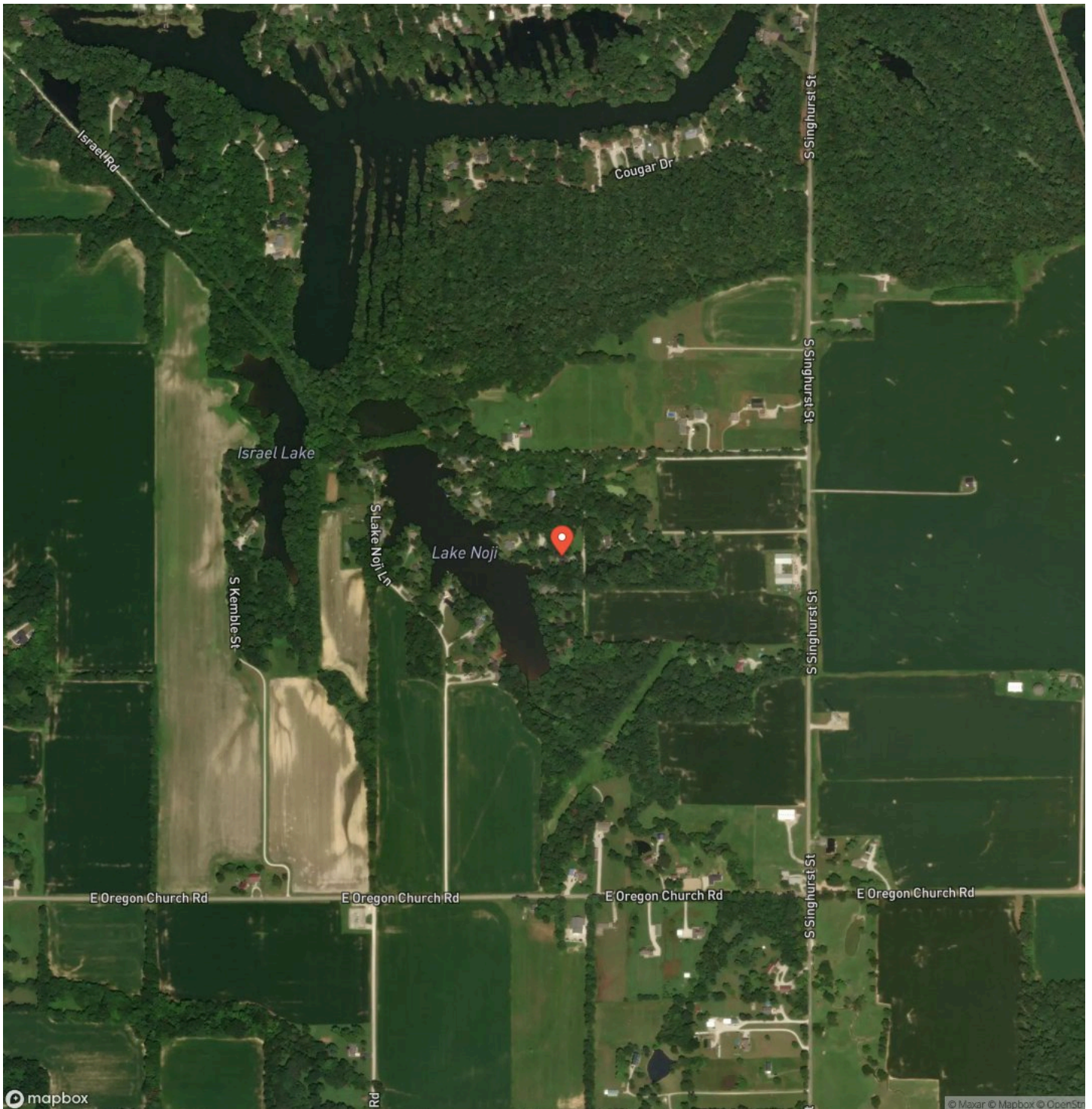
Locator Map
