A 318.6 ACRE TRACT OF LAND SITUATED IN SECTION 87, BLOCK 1, H&TC RR CO. BEGINNING: at a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING") at the southwest corner of Section 87 being 13.78 feet north of an old fence line, from which a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING") at the southwest corner of Section 80 bears South 12°44'17" East, a distance of 5286.86 feet, and a 1/2" iron rod (set with cap marked "PATRIOT SURVEYING") being in the west line of Section 80 bears South 12°44'17" East, a distance of 2643.24 feet;

THENCE: North 14°49'26" West, for a distance of 5245.60 feet, with the west boundary line of Section 87, to a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING") on the south right-of-way line of State Highway 92, from which a P.K. nail (found with washer marked "PATRIOT SURVEYING") at the northwest corner of Section 87 bears North 14°49'26" West a distance of 50.00 feet, from which a 1/2" iron rod (found) at the northwest corner of Section 92 bears North 11°12'04" West a distance of 5289.87 feet;

THENCE: North 76°36'47" East, for a distance of 106.09 feet, with the south right-of-way line of State Highway 92, to a 1/2" iron rod (set with cap marked "PATRIOT SURVEYING");

THENCE: South 13°23'13" East, for a distance of 15.00 feet, with the south right-of-way line of State Highway 92, to a 1/2" iron rod (set with cap marked "PATRIOT SURVEYING");

THENCE: North 76°36'47" East, for a distance of 1100.00 feet, with the south right-of-way line of State Highway 92, to a point for corner, from which a concrete monument (found) bears South 72°01'54" West, a distance of 1.89 feet;

THENCE: North 13°23'06" West, for a distance of 15.00 feet, with the south right-of-way line of State Highway 92, to a 1/2" iron rod (set with cap marked "PATRIOT SURVEYING");

THENCE: North 76°36'47" East, for a distance of 788.00 feet, with the south right-of-way line of State Highway 92, to a 1/2" iron rod (set with cap marked "PATRIOT SURVEYING");

THENCE: South 13°23'13" East, for a distance of 15.00 feet, with the south right-of-way line of State Highway 92, to a concrete monument (found);

FRANKS, DATED MARCH 1, 2018, RECORDED IN INSTRUMENT NO. 180272, OFFICIAL PUBLIC RECORDS, FISHER COUNTY, TEXAS, AND DESCRIBED MORE PARTICULARLY BY METES AND BOUNDS AS FOLLOWS:

THENCE: North 76°45'31" East, for a distance of 1313.23 feet, with the north boundary line of Section 80, to a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING"), at the northwest corner of that certain called 79.684 acre tract as described in Instrument No. 210404, from which a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING") at the northeast corner of the above mentioned 79.684 acre tract bears North 76°45'31" East, a distance of 1313.23 feet;

THENCE: South 12°46'51" East, for a distance of 2641.89 feet, with the west boundary line of said 79.684 acre tract, to a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING"), from which a 1/2" iron rod (found with cap marked "PATRIOT SURVEYING") at the southeast corner of said 79.684 acre tract bears North 76°42'02" East, a distance of 1315.22 feet;
