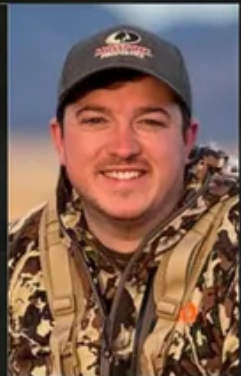

Rare 0.40 Acre Building Lot | Lancaster, Ohio

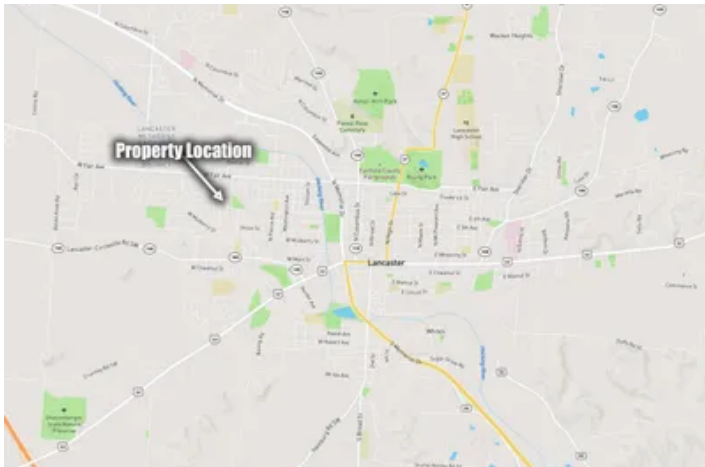

The lot is steep and slopes down towards the rear, making it well-suited for a home with a walkout basement, similar to neighboring properties.

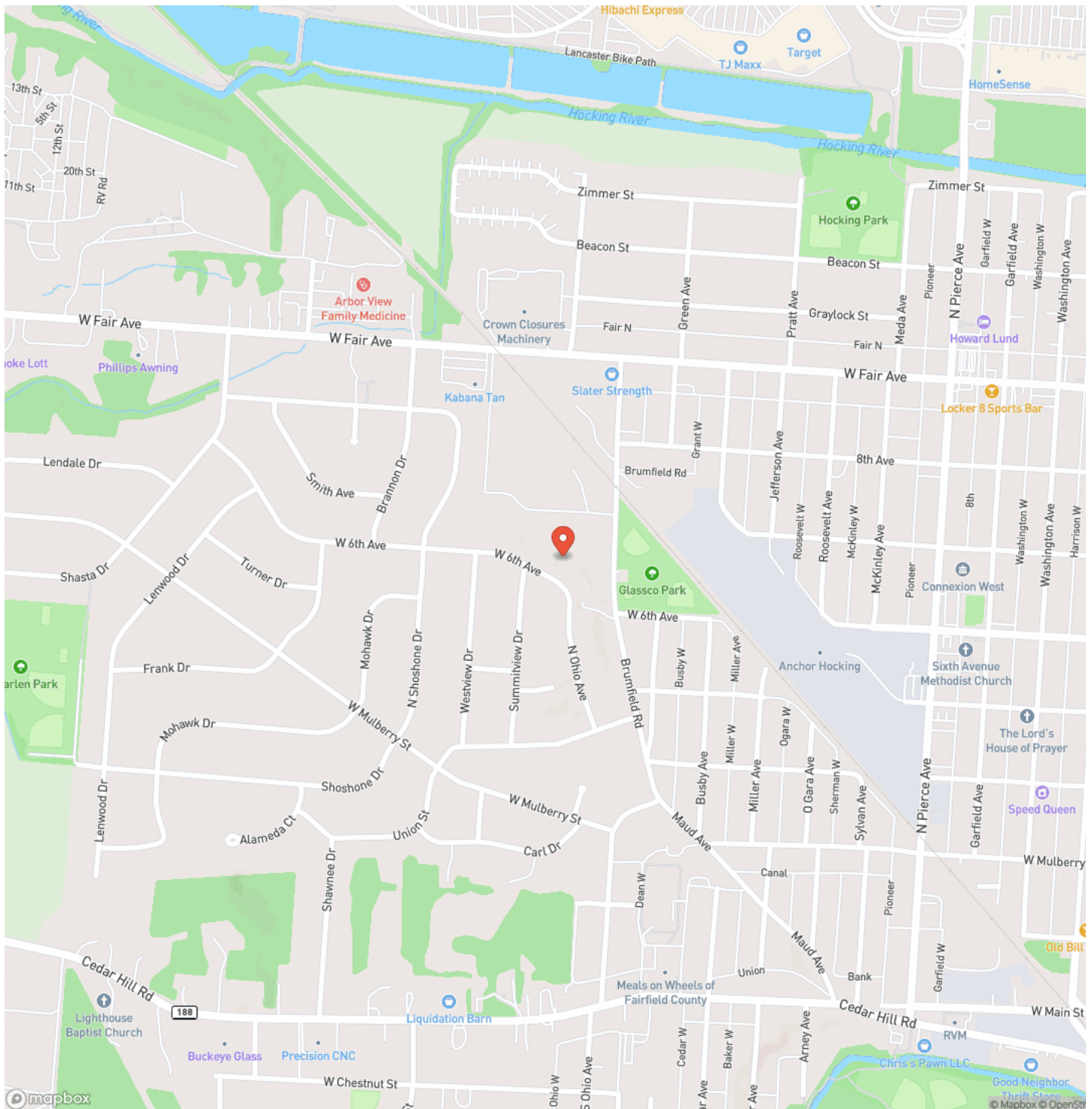
Electric and cable service are available at the road. Stormwater and city sewer run along the property line from North to South.

An adjoining 0.60-acre lot is also available for purchase, allowing buyers to own approximately one acre in town.

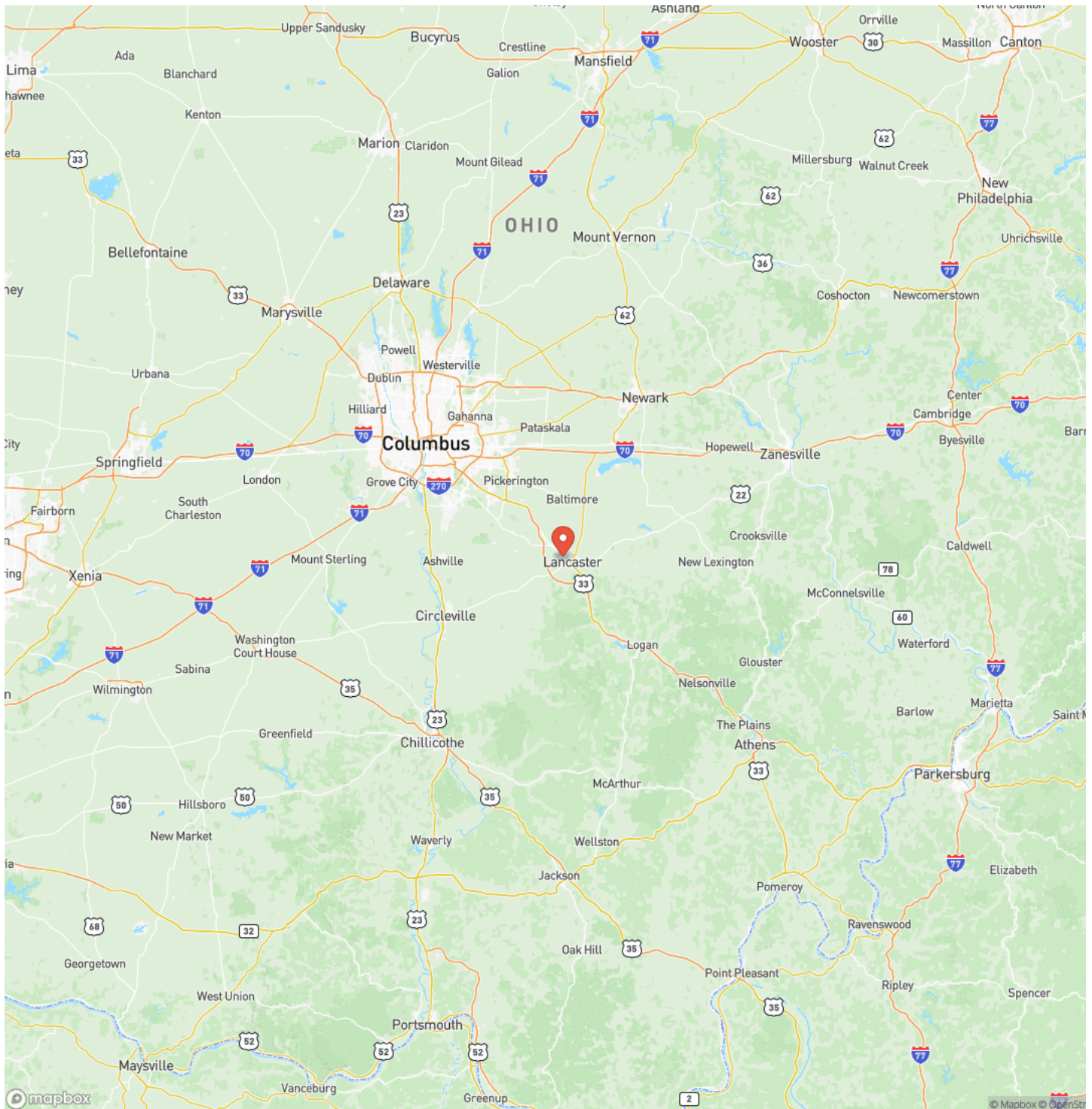

Locator Map

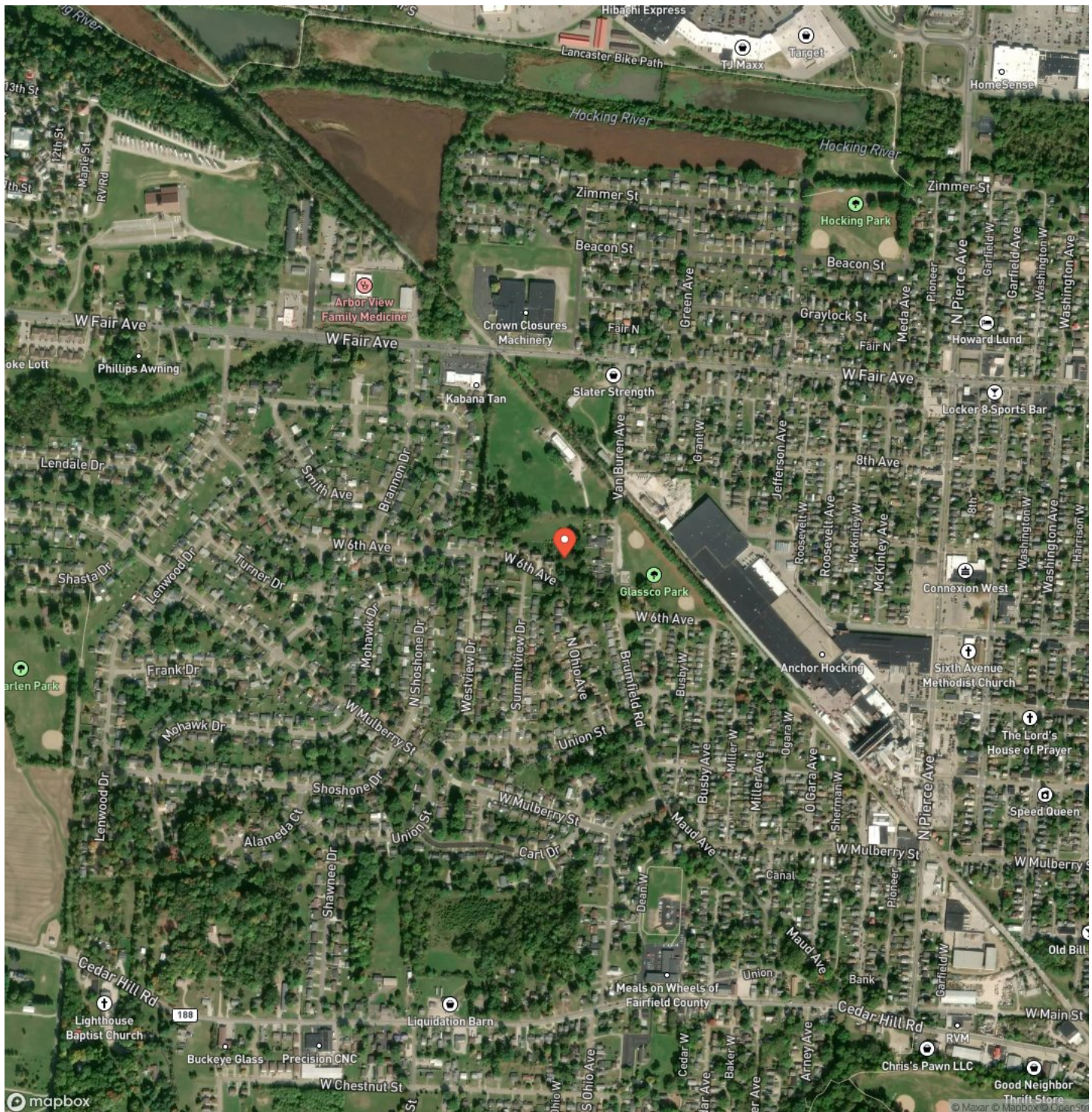


Locator Map
