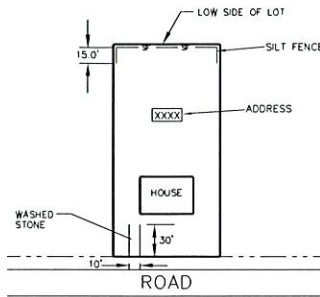


# SEPTIC TANK NOTE:

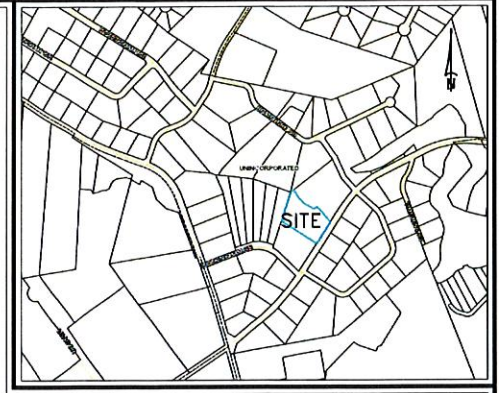

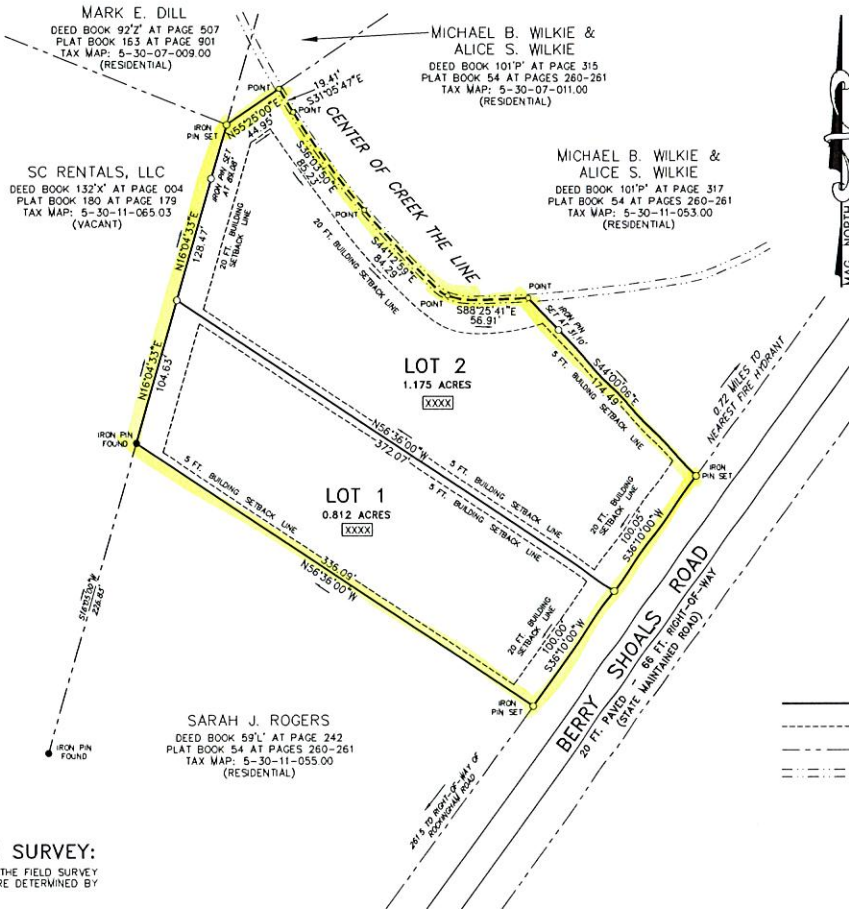

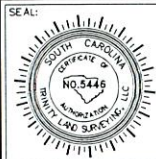
