Looking to add to your present farming operation or future build/acreage site close to South Lincoln? Located just 20 minutes southeast of south Lincoln are 73 +/- acres of gently rolling farm ground located in Otoe County, NE.

The property borders State Highway 66A on the east side and is located 5.4 miles south of Palmyra, NE. It is also supported by electrical service at the property line plus rural water service.







### **More About this Property:**

The property is a dry farm and has been in corn and soy bean rotation. The ground is made up of predominantly Pawnee Clay Loam and Wymore Silty Clay with 4 to 8% slopes. The naturally low areas have good wide stands of grasses reducing the potential for erosion. Additionally, the property is terraced and does have drain tile in place. The property at 73 +/- acres is 95% farmable with only 3.38 acres of waste.

The input costs for the property are in place and the property will be planted this year in corn, the current owner is willing to pay a "cash rent" amount after harvest to the new owners.

From Bennet, NE head South on HWY 43 to Martell Rd / K Road turn left onto Martell Rd / K Road and go 6 miles to South 8th Road turn right or head south for ½ mile property is on the west side of the road.












### Soils Map
