The tupelo gum and cypress brake timber create the ideal duck habitat. Surrounded by agricultural fields, water is retained year-round. Six established duck holes are in place with the potential to add more. Although a boat ramp exists, it needs minor work. Of the 112± acres, there are 26± acres of precision-leveled farmland. This farmland can be irrigated with a re-lift pump from the brake. The seller is willing to rent back the land for an agreed upon lease. If chosen to bypass the passive income opportunity, the farmland would be an ideal place to establish a dove field.




