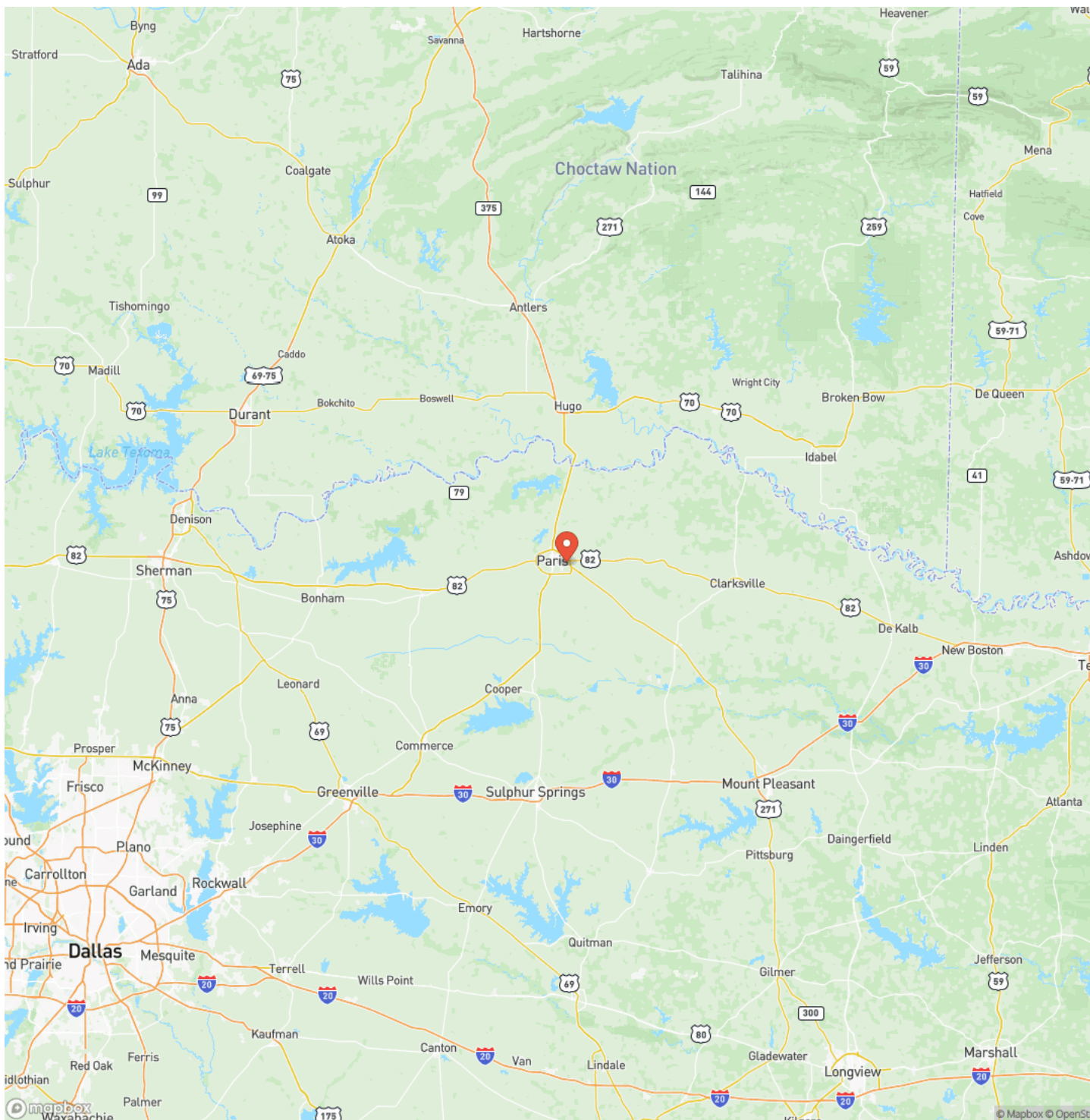
Locator Map

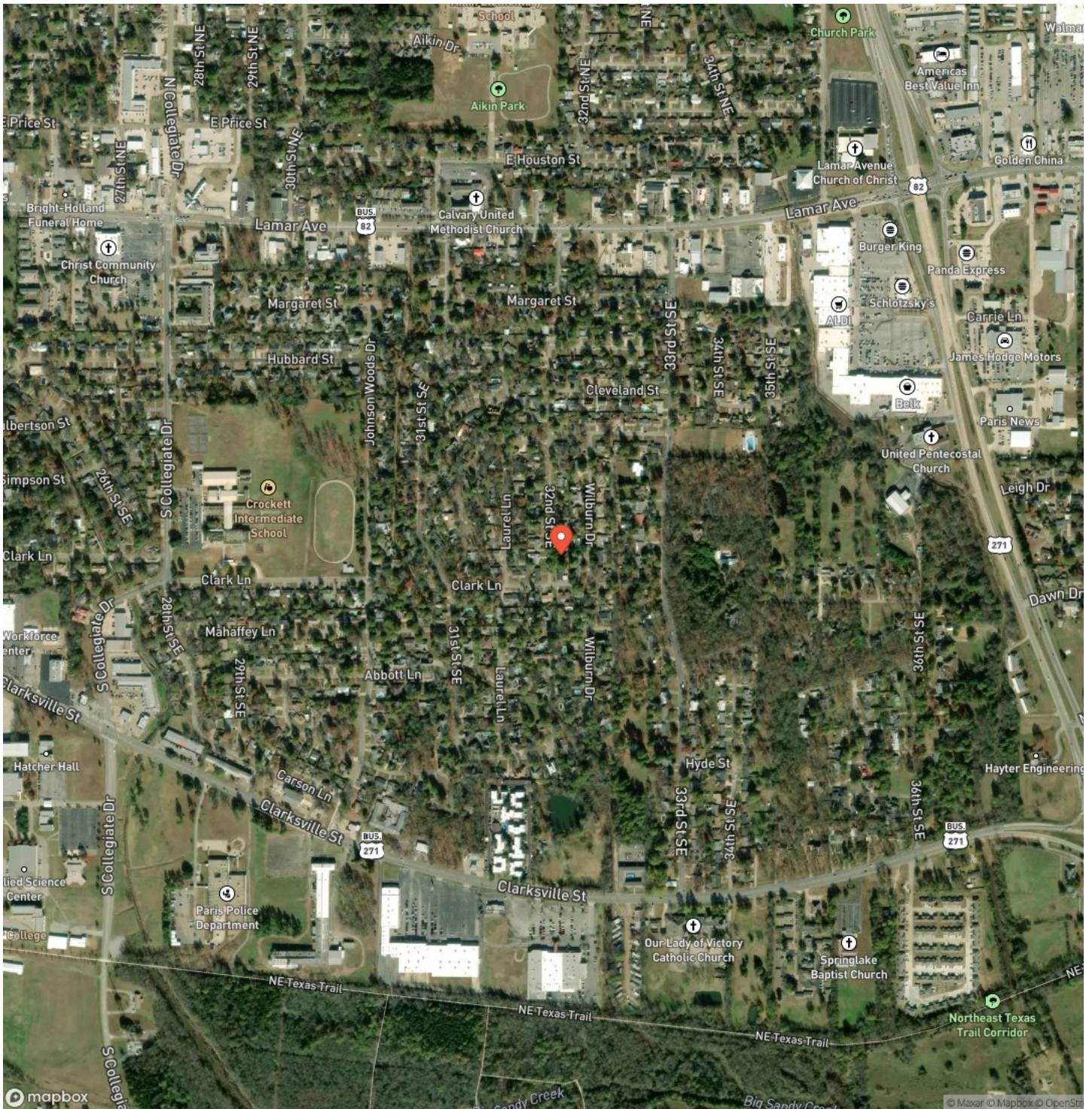
Locator Map
