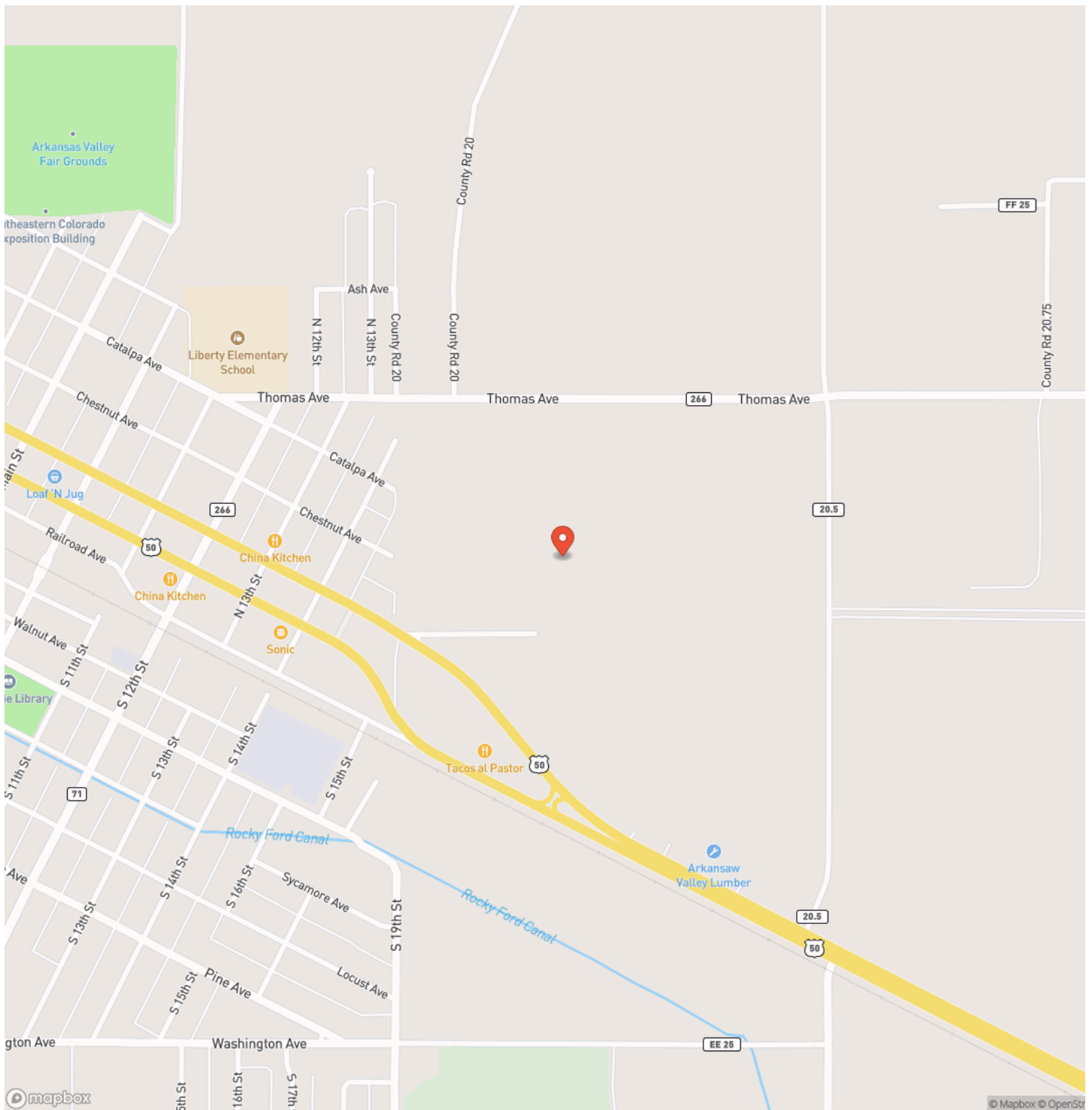
PROPERTY DESCRIPTION

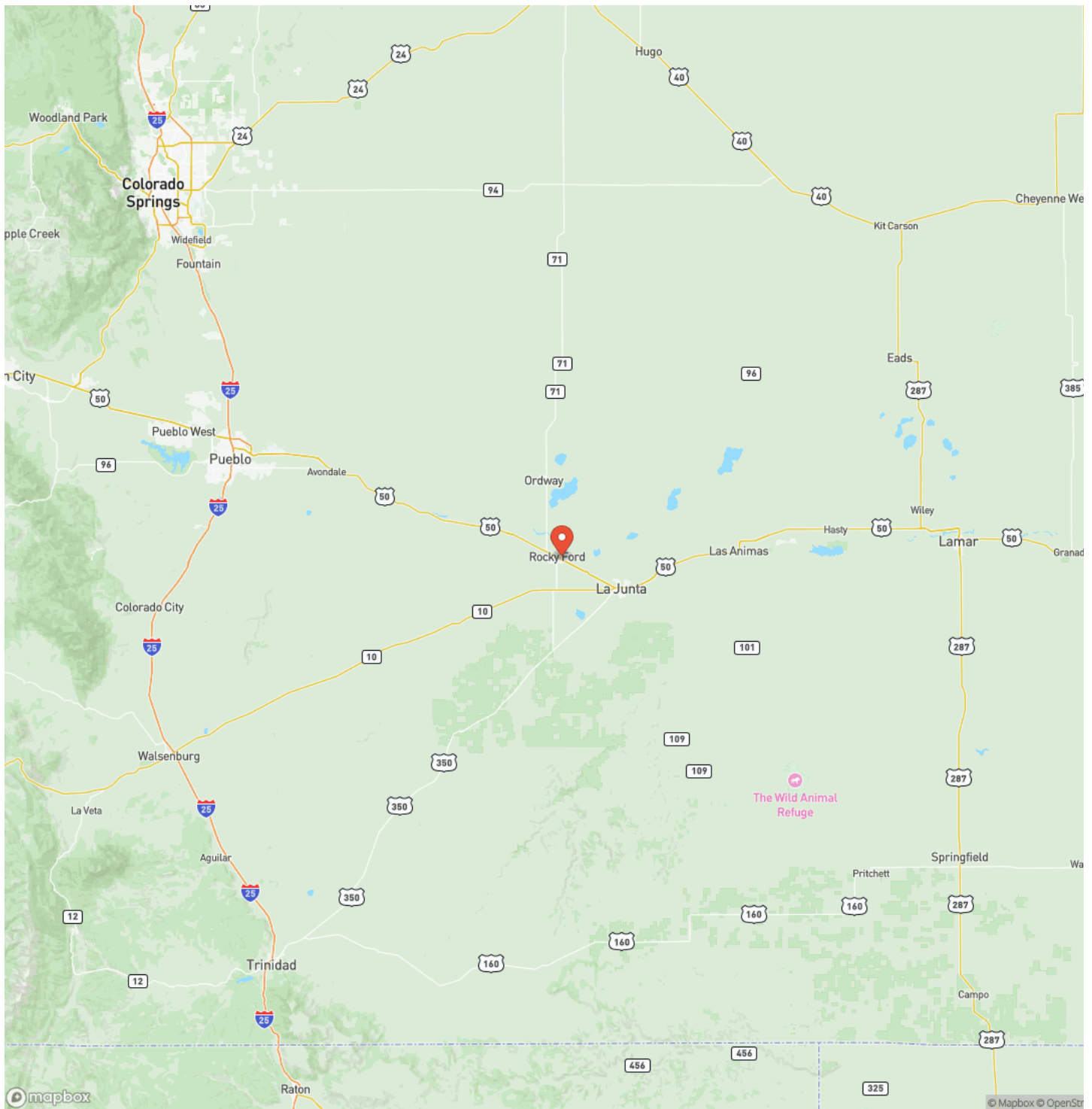




Locator Map
