1. Matters of zoning and local land use ordinances and regulations affecting the property, as well as any state/federal law matters restricting the use of any portion of the subject property which may be designated as "wet lands" or "flood zone";
2. Matters of record, licenses, cemeteries, and access thereto, easements, rights of ways, conditions and restrictions affecting the property;
3. Subject to all outstanding oil, gas and other mineral and/or royalty rights, interests and leases of record;
4. All matters which would be revealed by a current and accurate survey of the property, including but not limited to the location of boundary lines, improvements and encroachments, if any;
5. Subject to rights of others in and to the free and uninterrupted flow of creeks or streams adjoining or running through the property; and
6. Current year's ad valorem taxes and rollback taxes, if any.

SAVING, RESERVING AND EXCEPTING from the above described property is the following:

1. This conveyance is subject to the reservation of Telecommunication rights as set forth in that certain deed dated June 25, 2001, from SP Forests, LLC, to Edwards Land & Timber, LLC and recorded in Book 878, Page 613, Chatham County Registry.
2. The reservation by International Paper Company of an undivided fifty percent (50%) royalty interest for a forty (40) year period in the oil, gas, hydrocarbons and mineral substances and said reservations are more particularly described in a deed from International Paper Company dated June 25, 2001 and recorded in Book 878, Page 600 Chatham County Registry. It is understood that the Grantor herein has been granted an option for a period of ten (10) years from this date to purchase all but not less than all of the minerals in which real property is located at the rate of \$25.00, per acre and further that of the Grantor exercises its option to purchase mineral rights in any of the real property in a County, it must purchase all of the mineral rights reserved by International Paper Company reserved in that County. In the event the Grantor exercises that option for the County herein then the Grantee herein shall have the option of purchasing the mineral rights for the property described herein for \$25.00 per acre, provided, however, the grantee must purchase all of the mineral rights for the tracts described in this deed.
