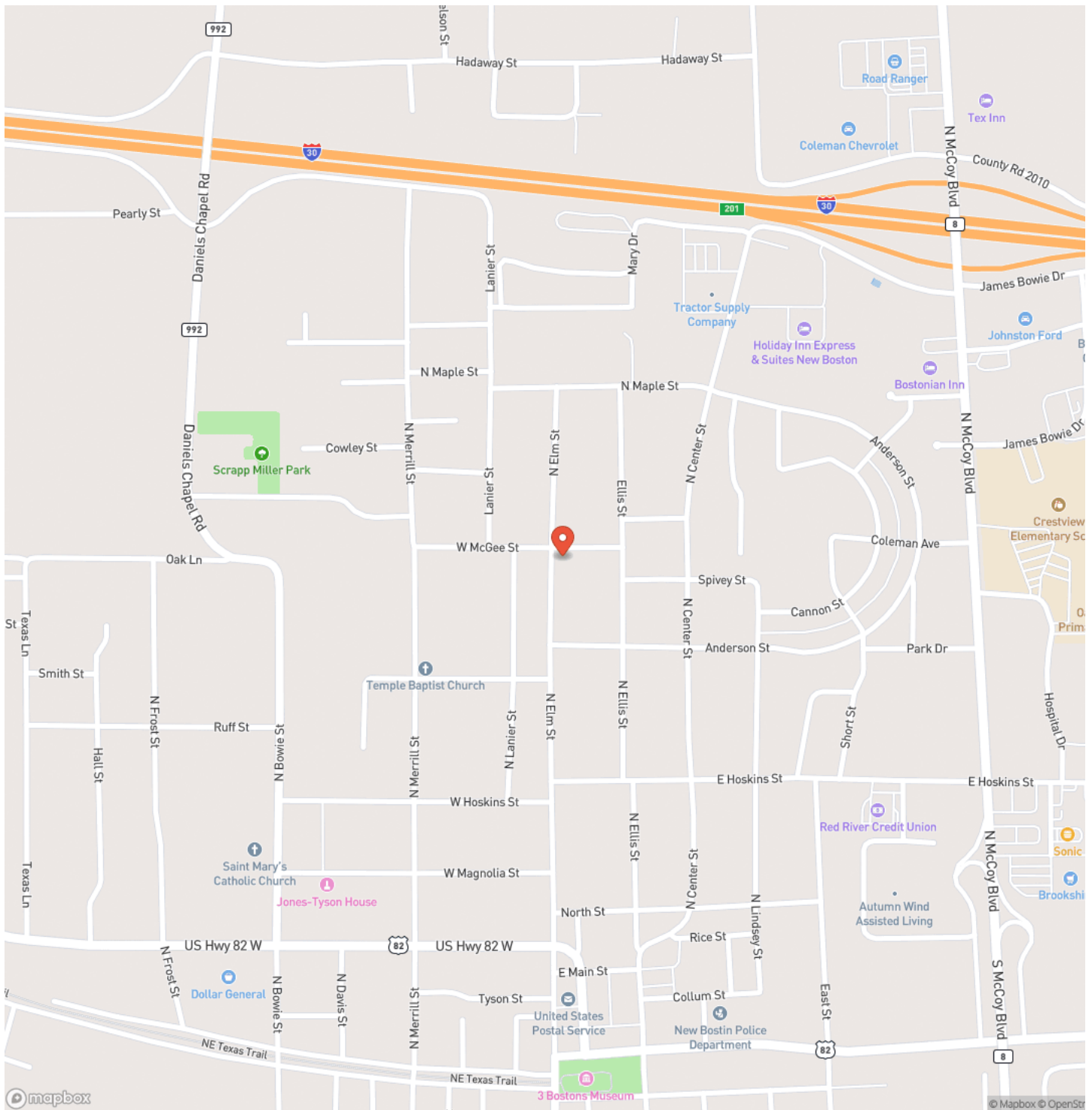

Locator Map

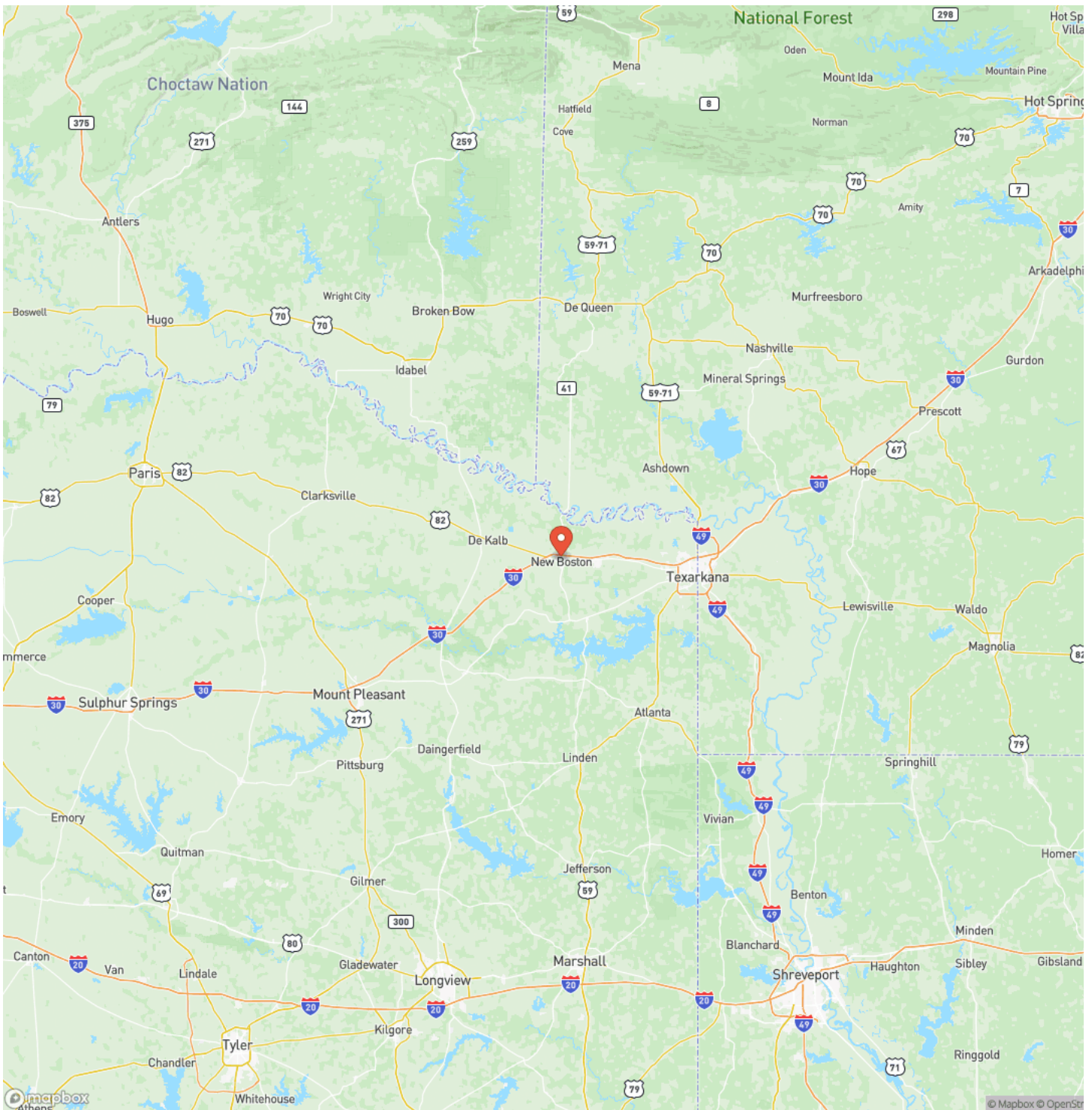

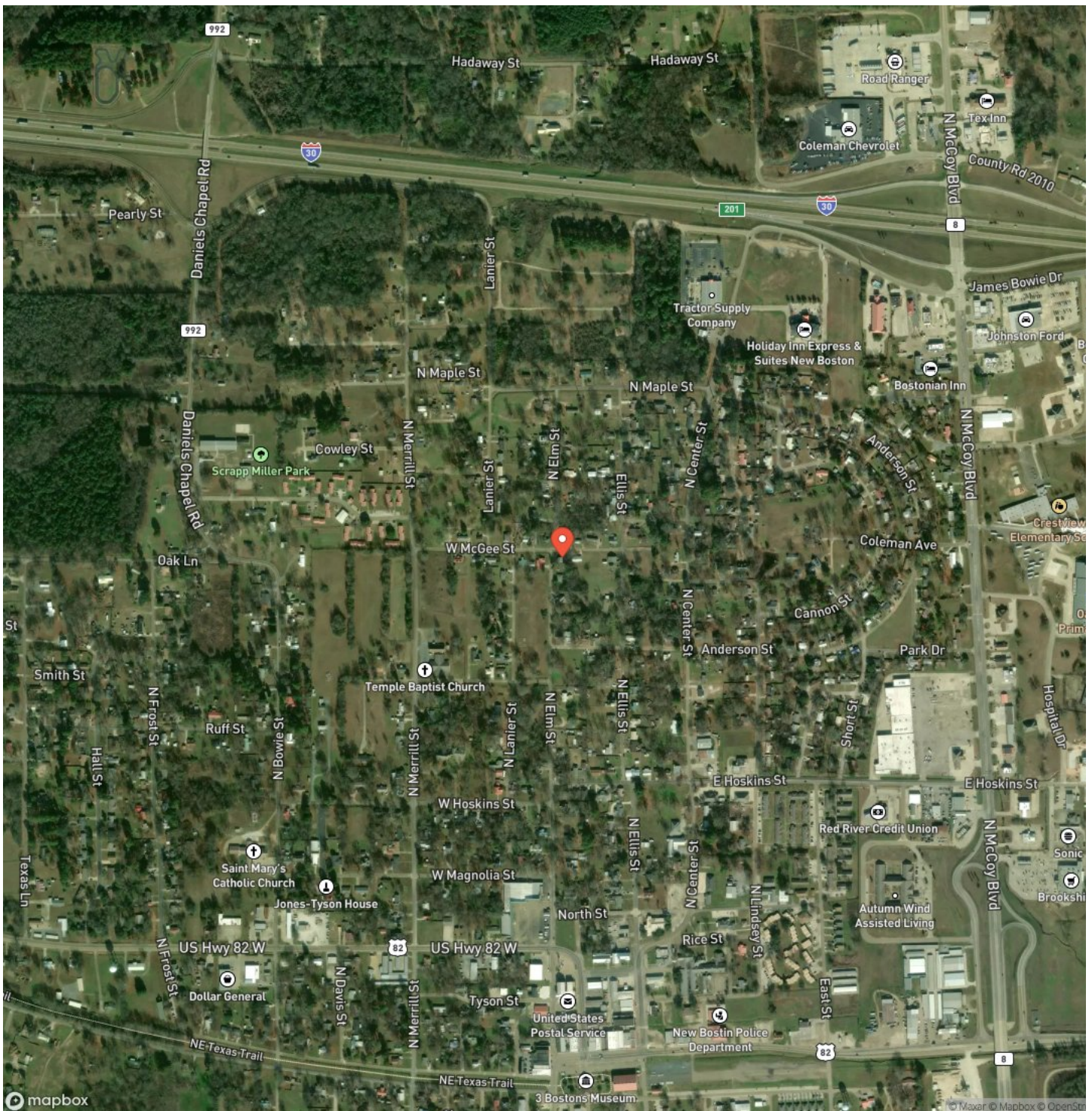
