thence southerly, along a tangential curve concave to the east, radius 3769.73 feet, central angle 00 degrees 59 minutes 24 seconds, 65.14 feet, said tangential curve being the circular equivalent of, and being very nearly parallel with, the Euler spiral curve center line of said Soo Line Railroad, said spiral having a central angle of 00 degrees 59 minutes 24 seconds and a spiral length of 99.00 feet;

thence southerly, along a compound curve, radius 2814.79 feet, central angle 03 degrees 38 minutes 27 seconds, 178.87 feet to the south line of aforesaid Northwest Quarter of Section 17 and there terminating.
