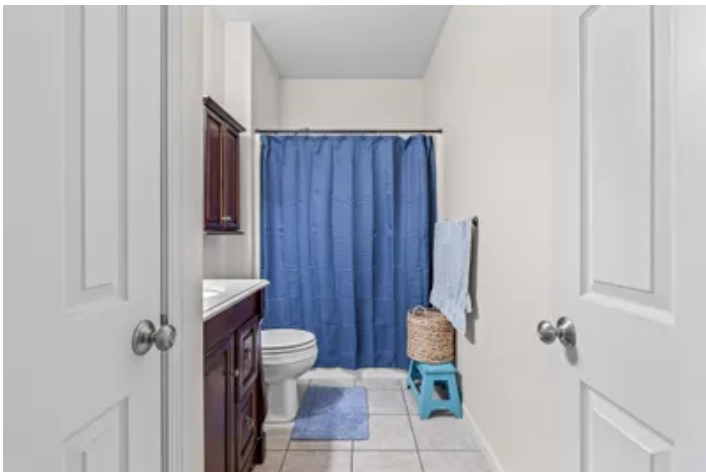

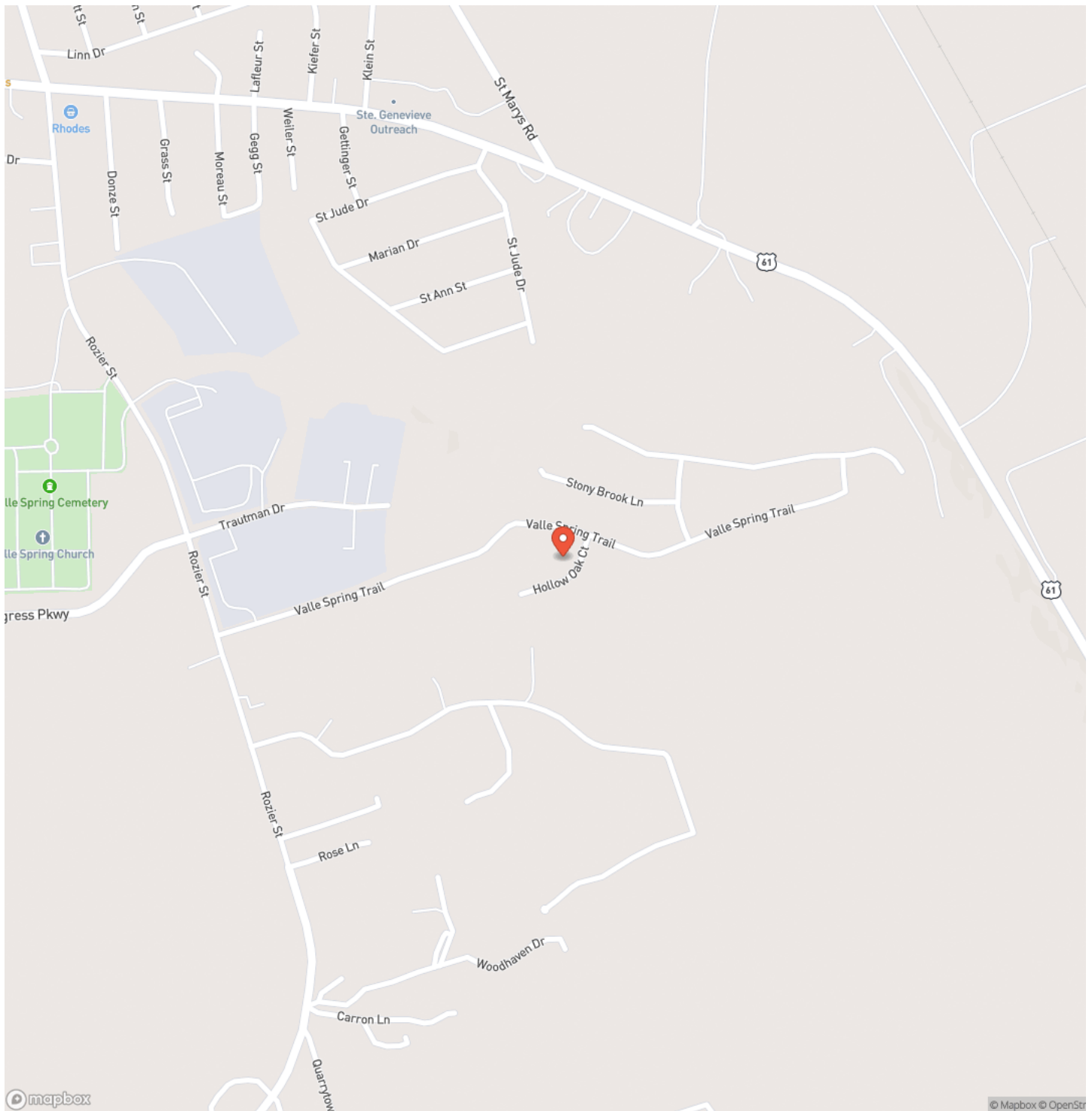

Locator Map

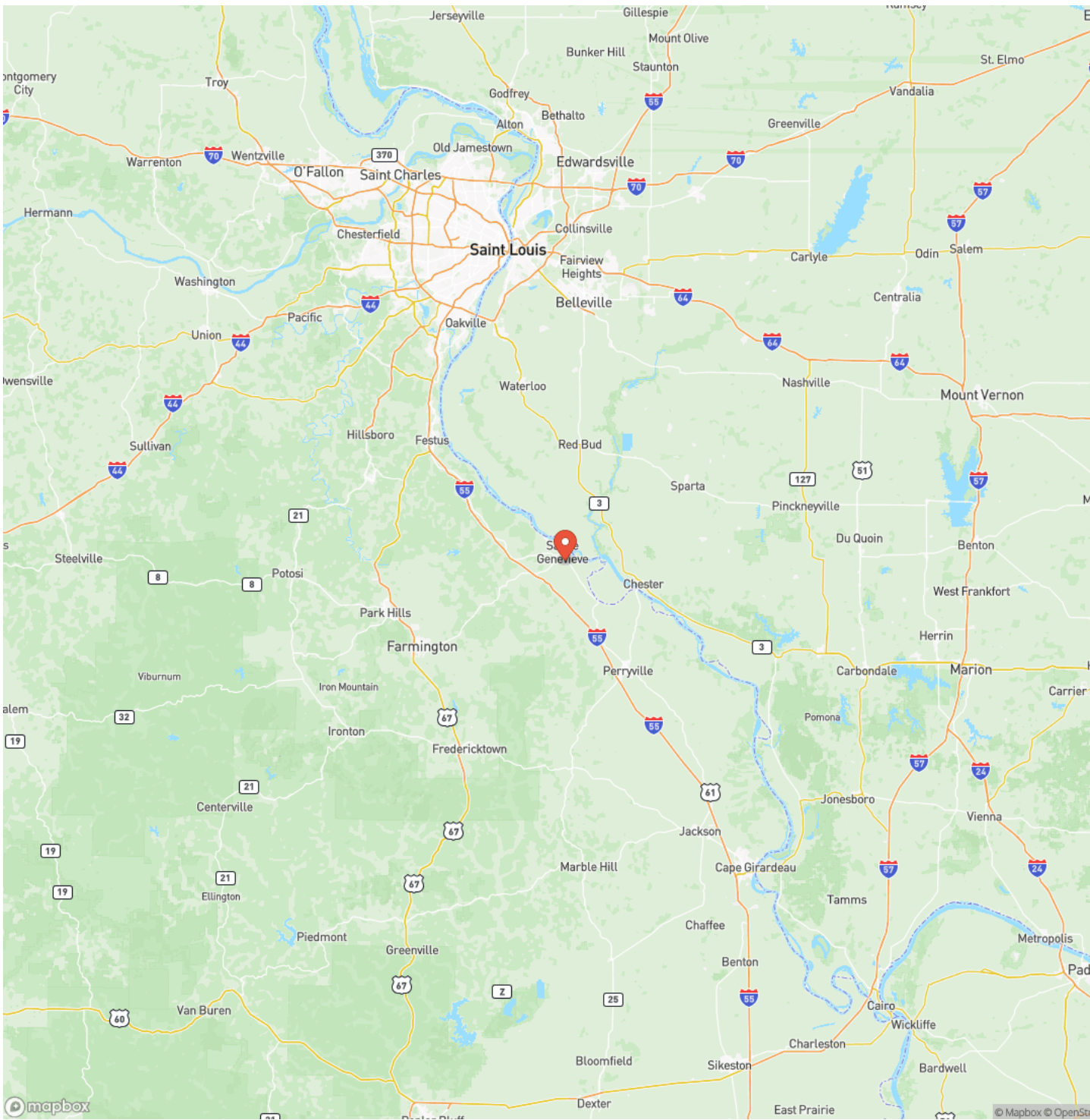
