Ny Dahl.of the state Texas, hereinafter called Party of the Second Part,

WITNESSETH: That the said party of the first part, for and in consideration of the sum of Ten Dollars and other valuable considerations, to it paid_

HAVE GRANTED, SOLD AND CONVEYED, and by these presents do Grant Sell and Convey unto the party of the second part and their heirs, and assigns forever; subject however to the conditions and covenants hereinafter contained, a certain lot of parcel of land situated in the County of Kerr and State of Texas, and out of a two hundred (200) acre tract conveyed to party of the first part, and by it subdivided into Lots and Blocks, to-wit:
