LEGAL DESCRIPTION OF A TRACT OF LAND IN HAMILTON COUNTY, TEXAS.

No. 1168 in Hamilton County, Texas, including 0.54 acres situated within County Road 425, and being part of a 112 acre tract of land described as First Tract and a 102 acre tract of land described as Second Tract in a deed from Robert Jolley, et ux, to Edward H. Seale, III, et ux, dated April 28, 2005, as recorded in Vol. 385, Page 1 of the Official Public Records of Hamilton County, Texas; said 30.99 acres being more particularly described as follows;

BEGINNING at a cotton spindle set in the approximate centerline of said County Road 425 and being on the north line of said 102 acre tract, from whence a 1/2 inch iron pin with cap marked "MAPLES RPLS 5043" set at the intersection of the approximate centerlines of County Road 424 and County Road 425 for the northwest corner of said 102 acre tract brs. North 71° 36' 27" West, 686.35 feet;

THENCE South 71° 36' 27" East, with the approximate centerline of said County Road 425 and the north line of said 112 acre tract, 1192.79 feet to a cotton spindle set;

THENCE South 18° 23' 33" West, 18.00 feet to a 4.5 inch pipe corner post on the south line of said road;

THENCE South 23° 20' 25" East, with fence, 31.19 feet to a 4.5 inch pipe corner post;


THENCE South 15° 56' 32" West, with fence, 858.71 feet to a 4.5 inch pipe corner post;


