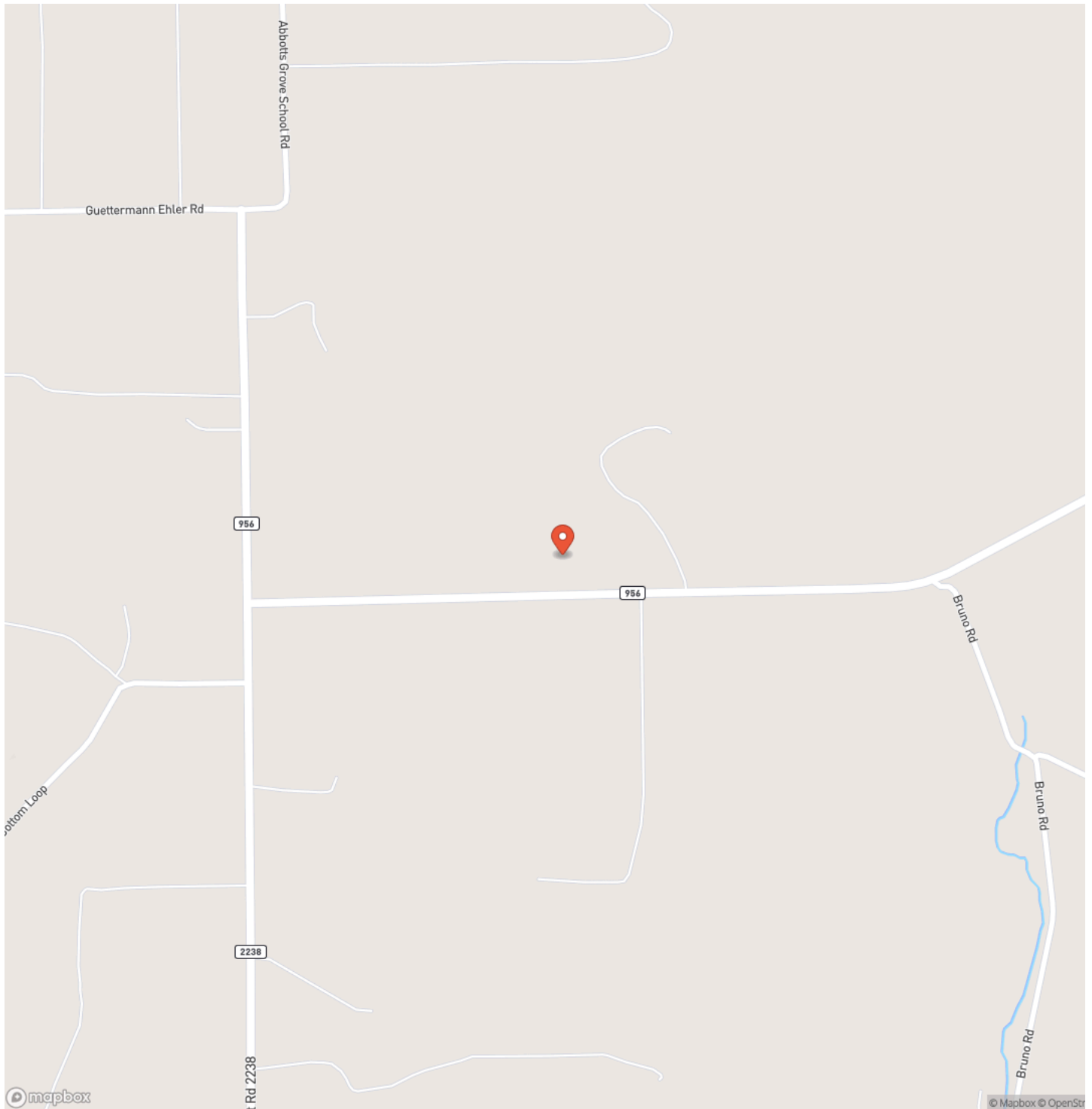

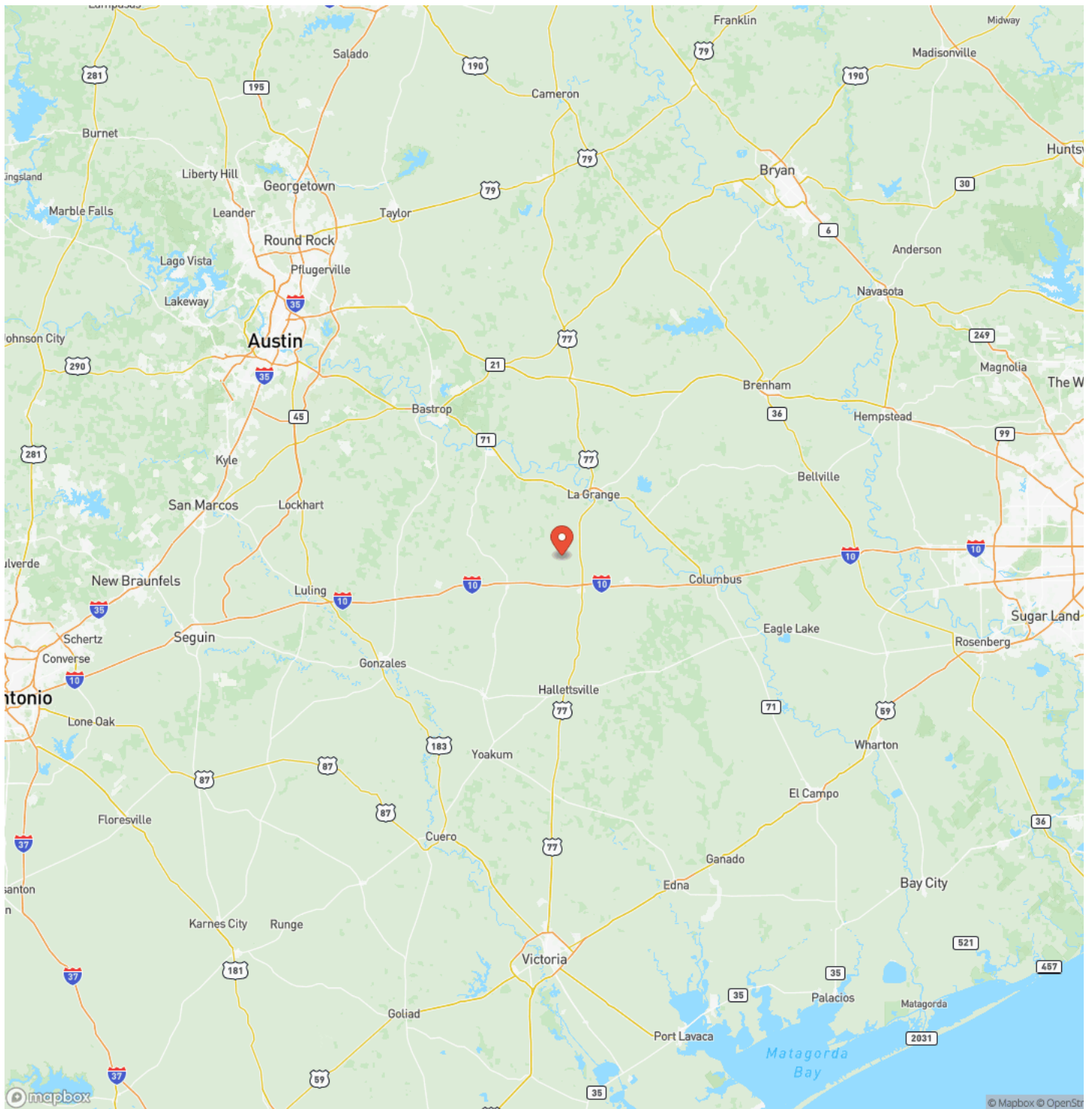


Locator Map



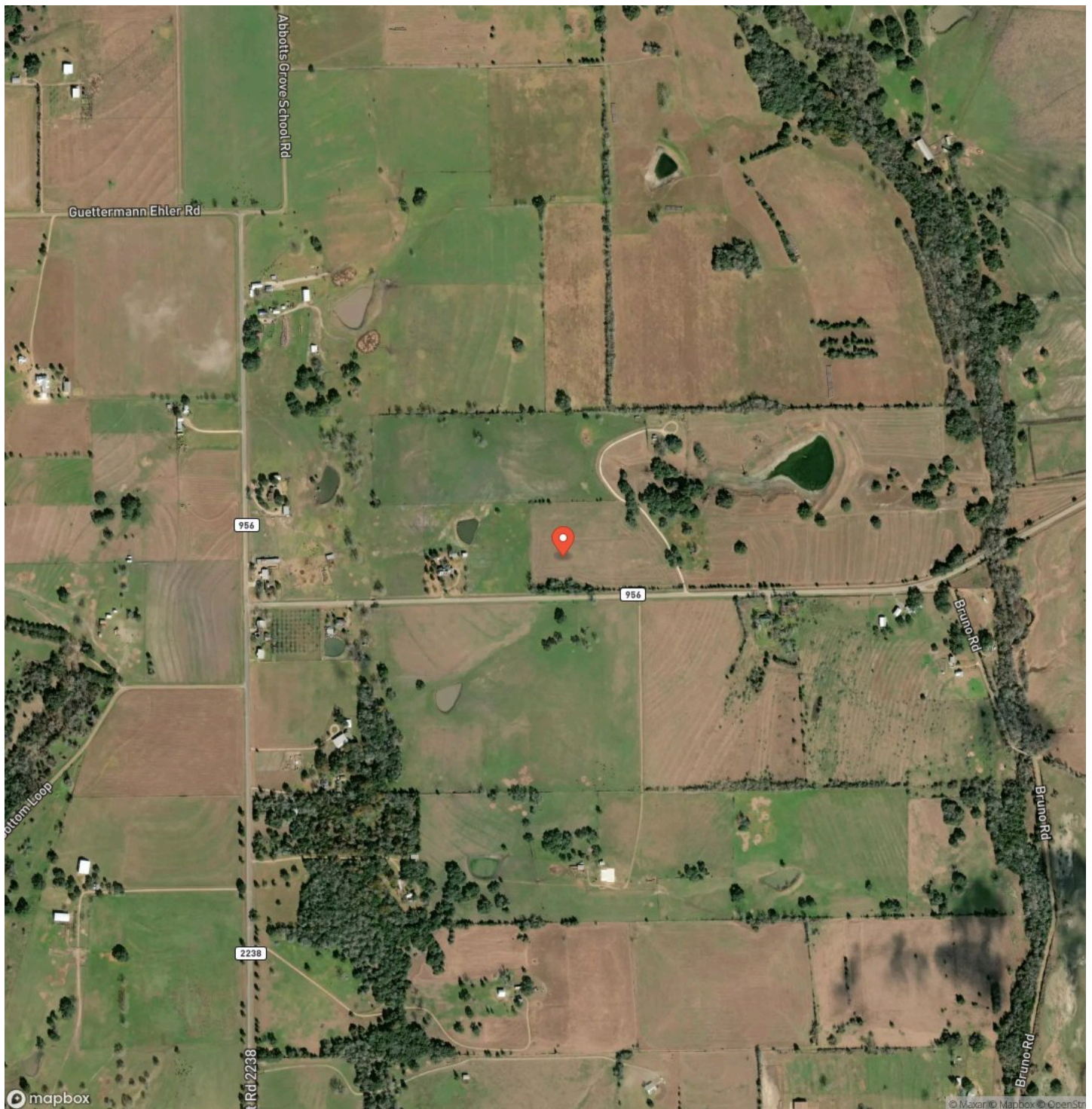
